**BROOME COUNTY LEGISLATURE  
SPECIAL SESSION  
NOVEMBER 28, 2005**

The Legislature convened at 5:04 p.m. with a call to order by the Chair, Daniel A. Schofield. The Clerk, Louis P. Augostini, read the fire exit announcement and called the Attendance Roll, Present-17, Absent-2 (Hull, Reynolds).

Mr. Shafer made a motion, seconded by Mr. Schafer, to override the County Executive's Veto Objection No. 2 re: Provide Funding, as Requested, to Add a Paralegal Position to the District Attorney's Department. **Motion to override Objection No. 2 carried**, Ayes-17, Nays-0, Absent-2 (Hull, Reynolds).

Mr. Shafer made a motion, seconded by Mr. Miller, to override the County Executive's Veto Objection No. 3 re: Do Not Downgrade Director of Transit Operations. **Motion to override Objection No. 3 failed**, Ayes-11 (Keibel, Schafer, Miller, Shafer, Nannery, Howard, Kuzel, Marinich, Lindsey, Mather, Schofield), Nays-6 (Materese, Hutchings, Whalen, Sanfilippo, Brunza, Buchta), Absent-2 (Hull, Reynolds).

Mr. Schafer made a motion, seconded by Ms. Nannery, to override the County Executive's Veto Objection No. 4 re: The Legislature's Increase of Appropriations to the Veterans Support Council by \$15,000. **Motion to override Objection No. 4 carried**, Ayes-16, Nays-1 (Kuzel), Absent-2 (Hull, Reynolds).

Mr. Sanfilippo made a motion to adjourn, seconded by Mr. Brunza. **Motion to adjourn carried**, Ayes-17, Nays-0, Absent-2 (Hull, Reynolds). The meeting was adjourned at 5:32 p.m.
