- 3.) Opioid -Related Public Health Surveillance:** Dr. Chris Ryan, MD, MS; BCHD
 1. Opioid involved deaths among Broome County residents as defined locally by drug word mentions
 - 2011-2018 by quarter, 1st quarter less than eight
 - Problems/concerns-lag time in death certificate data that is "pending" could be opioid overdose death
 - The definitions are from state and epidemiology
 - Quarterly counts 2015-2017

2. Law enforcement Naloxone administered in Broome County
 - Recent decline in 2017-2018
3. EMS Naloxone administered in Broome County
 - Trends: Recently have gone down significantly
 - Limitations: Non-clinical people who are trained in Naloxone use may be bringing the EMS responder counts down, patient may overdose and no call is made to EMS
 - Dr. Hunter - Can physicians be trained on completing death certificates?
 - Dr. Ryan – 85% of death certificates are completed by coroners.
 - There are trainings and resources for those who fill out death certificates.

4.) Committee Updates

- **Community Education:**
 - All school event: no date set, details to follow
 - Sports forums: Chenango Valley in August
 - All schools were offered, and ordered, graduation cards for graduation season to reduce underage drinking; cards have been distributed. Messages for students and parents
 - Broome County does not have a social host liability law
 - Parents need to know liability involved with serving minors
 - These are civil and criminal laws

- **Membership Committee, Media and Advocacy Committee, Law Enforcement Committee, and Data and Statistics Committee:** No reports

- **Treatment and Prevention Committee:**
 - Dr. Hunter – BUP Waiver Training: 26 providers total, 14 from UHS
 - Offering support to UHS inventory
 - Contraception now offered in methadone clinic, rebranded it as birth control clinic
 - UHS provides an OB at methadone clinic; services provided by Charlene Grier
 - Dr. Hunter suggested providers attending BUP waiver also attend Hep C training
 - Dr. Bank (GI) is now providing Hep C treatment in methadone clinic at UHS
 - Dr. Hunter and Ronan providing BUP training to medical residents and are thinking of doing Hep C training
 - Wendy Hunter – SBH – (Syracuse Behavioral Health)
 - Narcan training sessions will be held at SBH and SBH can go out into the community to provide
 - SBH barbeque on August 10, 2018 - Shuttles are available, tours will be given
