

Broome County Safe Housing Task Force – Core Group Tuesday, November 13, 2-3pm Meeting Minutes

• Progress updates

- Tom: Spoke to the director in Rochester re: rental registration. Couple points of interest –
 - In place since 90's with modifications, process is unique in that code enforcement is not separate from buildings department
 - Each code officer is assigned portion of parcels (in COB it's by neighborhood/electoral district). Rochester said 300 cases per worker per year.
 - Salary is significantly higher which does impact work performance and longevity
 - Administrative legal process (ticketing system, not court system), case load conversation
 - Mark state mandate that everything is on a tablet, saved a lot of time for Healthy Neighborhoods
 - What key modifications have been made since 90's? Rental community has adjusted over time. Is it a barrier in COB that buildings/code is separate? Tom and Chris didn't see any advantage. Assignment approach opinion? Tom notes 14,000 structures, 2700-4900/inspector. Only COB, TOU, and Vestal have full time code staff.
- Rebecca: Spoke briefly with Code Enforcement Director in Syracuse, hoping to follow up and will share a larger conversation at a later time. Also spoke with Katie



Bronson of Greater Syracuse's Green & Healthy Homes Initiative (GHHI) – examples of how they're supporting rehab financing, collaborating with landlords to positively incentivize, etc. GHHI Action Plan extremely comprehensive but covers similar topics to ongoing Task Force discussions and began with a similar collaborative effort (see attached). Rebecca also met with the regional VP and JC Branch Manager of Community Bank – they're interested in the action plan we submit in regards to financing support. Spiegel Notification protocol remains in process.

- Sharon: Followed up with JC so civil court approach re: Spiegel statutes are similar. Spoke to someone in Syracuse re: Revolving Rehab Financing information, will pick her brain more.
- Shared Database Development
 - DSS Caseworker Structure
 - Code training from Binghamton so they know what to notice inside people's homes.
 - First come, first serve in CPS assignments.
 - Tonia suggests release of information to share between agencies. What are the legal barriers to that?
 - Property owner information (rental registration)
 - Who else has a stake in that? DSS, school district, Health department, etc.
 - Difference in usage operational (service) vs. strategic (policy formation)
 - Center for Technology in Government
 - Working with intermunicipal project in Albany
 - Doug English, GIS
 - Access is already there for County and municipalities, folding in departments and school districts. It is adjustable to our needs, unlike state software.
 - Next step may be bringing him into the meeting to discuss.
 - Health Department
 - Lead violations, specifically. Contacting homeowners, sometimes including hiring the Sheriff's Office to make contact because home is owned by LLC, address is post office, etc.
 - Healthy Neighborhoods may see more than Code does because people are afraid to call Code.
 - o Information to Include
 - Lead violations
 - Owner info
 - Code violations (Building Blocks already tied to GIS)
 - Unique student codes
 - Occupancy info



- (Difference in data info code is location based, school and DSS is people based)
