1. Internal/External Correspondence Report

- b. Discussions with Doug English re: GIS capacity to host annual property registrations/potential for County/municipal data integration Per Mark, hard copy of registration &/or instructions for completing online survey (*Survey123*) could be sent out to owners of rentals with annual property tax information in 2020. Responses free of charge. Municipal quality assurance inspections could follow; eventual potential for occupancy inspections.
- c. City saw demo of another State database for code <u>MuniCity5</u> by CODE (Community Officials Data Exchange) that is cloud based and GIS compatible. Recommended for consideration.
- d. City specifically has been working on increasing homeownership, Source of Income legislation, Syracuse models, etc.
