Following the Resolutions, Mr. Baker noted that Mr. Ponticiello was unable to attend the Committee meeting so his update on the new State requirements regarding 911 Call Center Records will be pushed to the October Public Safety & Emergency Services Committee Meeting.

Additionally, Mr. Baker recognized Mr. Hilderbrant. Mr. Hilderbrant welcomed residents of the Town of Barker to the Committee meeting to share their concerns regarding the Sheriff's proposal to accept 60 acres in the Town of Barker for the purpose of a firearms range and training facility. He had previously sent a letter to residents asking them to provide any feedback they had on the proposed project. He further requested that the residents be granted time to share the concerns. Mr. Baker agreed and opened the floor to anyone who wished to be heard.

Mr. Ballard presented a petition to the Committee of over 70 neighboring residents of the parcel who are opposed to the proposed project. In addition to Mr. Ballard, Mr. Chilson, Ms. Lewis, Mr. Miller, and Mr. Stimak spoke as well. Some of the concerns they expressed included little to no notification from the Sheriff's Office on the proposal, potential noise and negative environmental impacts, decrease in property values, and limited time to comment on the proposal as many just received a letter from the Sheriff inviting them to a meeting two days later. Additionally, they requested that any meetings on this project be held in the Town of Barker for any resident who wants to be heard. A suggested location was the Town of Barker Town Hall.

Following the speakers, Mr. Baker and Mr. Hilderbrant thanked the residents who attended the meeting and shared their concerns.

There being no further business to come before the Committee at this time, a motion to adjourn was made by Mr. Pasquale, seconded by Mr. Whalen. The meeting adjourned at 4:29 PM.
