Re: Public Safety Radio System Update

#### Physical Infrastructure

Work is progressing on the next nine physical sites for the radio upgrade project. Please see the attached Site Development Checklist. We intend to build Nabinger, Sanford, Ely Park, and Laurel Lake this year.

### Site Acquisition:

We are in process of procuring via property acquisition or lease agreement the following sites to build out the system:

- Lisle (Town of Lisle): Property approved in July lease agreement with Law Department After some minor changes to the proposed road, the property owner has agreed to the lease and it is in his hands to sign.
- Maine (Town of Maine): Still acquiring property Waiting on a family of five to decide if they will accept terms. This has been an arduous site location in that nobody in the area wants a tower.
- Kirkwood (Town of Kirkwood): Property approved in July Easement request will be before legislature in September. Lease agreement has been approved verbally, waiting for review by the property owner's attorney and then signature. Easement with the adjacent property for an access road is being developed by the county attorney.
- Ely Park (City of Binghamton): Road construction complete. City has approved electric access to site. City code enforcement reviewing building permit.
- Nabinger (Colesville): Lease complete road construction complete, waiting for construction.
- Sanford (Town of Sanford): Lease complete, County Highway will begin work on the access road once Laurel Lake is complete
- Deposit (Town of Sanford): Still acquiring property Waiting on approval from 3 brothers who own the property.
- Laurel Lake (Town of Sanford): Property approved in June lease agreement with Law Department road construction has begun.
- Windsor (Town of Windsor): Property found, Lease agreement before legislature in August. Known NYSEG issue with property. Waiting on NYSEG proposal for electric routing.

### **Requests for Proposals**

There are two primary bids and one sole source contracts that cover the majority of this project. All bids have been structured for delivery of four sites in 2019 with addons of the remaining sites in 2020 in an effort to get the most competitive pricing.

- Towers and Shelters RFP was received, awarded to Saber for the first 4 sites.
- Construction RFP was received, award to Mid-State is in process for first 4 tower sites. First construction meeting scheduled for tomorrow.
- Generators (cooperative purchase) Purchase Order issued for the first 4 sites.

# Road Construction

The highway department has been an instrumental partner in constructing the roads to each of these sites.

#### Microwave

We have a contract with Aviat to install microwave backhaul to the new Ely Park site and to connect with Cortland County. There are also new microwave connections between our Hawkins site and the County Landfill and Airport for I.T. connections as part of the project. Final design approval is expected in the next 30 days installation to being early Fall.

#### Motorola Contract

Motorola, working with their subcontractor – VComm, have finalized the system frequencies. They are now working with the FCC to secure the necessary licenses. We are within the appropriate waiting time for FCC approval.

Emergency Services has identified the needed off system frequencies and has requested quotes for the necessary FCC licensing work.

OES staff have been designing preliminary talk path profiles for the end user.

OES and Motorola will begin working on the lease agreement for equipment in August. This is expected to be before legislature in late fall.
