- Broome County Health Department:
 - Very busy here with COVID, we are working on the new guidance and adjusting accordingly.
 - Reminders to get boosted!
 - Greek Life Update:

 - We are going to be reporting the numbers

- Prevention Coalition:
 - In our 6th year! Our main focus in marijuana
 - Working with Broome Tioga Tobacco program on updated local policies to include cannabis language
 - Working on safe
 - o Binghamton high school
 - Still working on Recovery High School
 - ACBC has been working with UE well
- SOR II
 - Looking at expanding Narcan access with take away kits for EMS.
 - Met with Dr. Ryan, Ray Serowick, and Kristin on how to expand.
- NIDA Healing Studies
 - Moved into Phase 0. Jillian has a meeting with Columbia in March so they will hear more soon.
 - Broome County Social Services and Mental Health
 - Housing
 - At a critical point, many people are needing help
 - Partnered with the United Way and it was a good initiative
 - Outreach efforts went well.
 - $\circ~$ RFP will be coming out on Renting supplements. Working on a plan in place
 - In the middle of Code Blue season, we're working on keeping everyone as safe as possible during this time
 - Working on SNAP applications
 - MH will be receiving money to develop a system of care. Working with Law Enforcement on those who are critically in need of mental health services

 - Drug Court:
 - \circ $\,$ Our drug court is continuing in the Binghamton Court
 - o 94 current participants
 - There are no current graduation dates
 - \circ In the process of hiring another person, and after that they will be willing to come
 - Treatment alternative program
- Broome County Probation:
 - Involved in the Drug Court team as well
 - POs are still out and working as usual, trying to survive COVID
- YWCA:
 - Bridge program:
 - \circ $\;$ Works with moms and children who are born addicted to substances
 - Helps moms with recovery and works with them
- Helio Health:
 - Helio is moderately full
 - Erica is trying to make connections with clothing banks because there are many patients are coming in without many clothing items. It has been a challenge finding available items for men.
