 - EBP
 - All Stars, Teen Intervene
 - 41 students were met with 1:1

- 7 series of ATOD presentations-82 students
- 14 classes of refusal skills
- Looking to triple those numbers--UE became a permanent site for all 3 locations

- Also provided training for the team: Too Good for Drugs (costly training) pilot training
- Working with 5th grade now, then 6th, 7th, 8th, 9th with prevention and intervention skills.

- **Family and Children's Counseling Services** –Emily Georgia, CASAC-A, ROAR Supervisor (Rapid Opioid Assistance in Recovery – Low Threshold) and Jessica Saeman, CASAC-T, CRPA Behavioral Health Clinician

- Overview of ROAR program
 - Get people on MAT and keep them engaged with as few barriers as possible
 - HR approach-maintaining access to treatment with flexibility
 - 45 min assessment, get to prescriber same day for Buprenorphine or Suboxone
 - Telehealth intakes available
 - All intakes get Narcan
 - Reduced expectations, especially number of monthly contacts
 - Treatment plan is focused on getting needs met
 - Referrals to programs beyond low threshold
 - Looks different for every client, keep them connected, meeting them where they are geographically too. Going to houses to check in if appt missed. If need ID to get meds.
 - CCBHC-access to case management and crisis services also
- New peer in Broome starting today
- BUPE-AP— covers cost of oral Bupe--FCCS can help anyone, no client requirement,
- Referrals
 - Can be a phone call that someone is interested-they will try to find them
 - Call Emily for in person or phone intake
 - Scheduled for same day focused assessment
 - Know about 1st appt before leaving try to have it while they are in the office
 - Getting info ahead of time can reduce barrier of waiting in the office.
- Jess
 - Earned CASAC and has been using that, was meeting people at the library, looking for places to meet people safely
 - Vending machine filled weekly: wound care, safe sex, feminine hygiene, Narcan and test strips
 - How has neighborhood responded?
 - High needs
 - Some days a lot of trash—asking for city to put garbage can there
 - Madelyn will bring that up with DPW--should work on that

4. Broome County Health Department Overdose Prevention Program Updates

- OOPP Data: 9 OOPPs in Broome County, 8 of 9 reporting
 - 1,519 people trained
 - 5,301 kits/10,602 doses give out this quarter (July-September)

- 2025 Total as of 9/30: 29,852! Surpassed all of 2024: 20,068
- BCHD Program Spotlight Video: Please see pinned post on Facebook.
- BCHD has Naloxboxes for anyone interested-small totes, newspaper stands and wall mount.
 - Let us know if you see empty boxes in the community so we can refill as needed.
 - We are getting questions about naloxone being outside--not worried about temps due to research that shows how little efficacy is lost.
- BCHD also has wound care and wellness and some undergarments and socks available
- If there is a group that wants to put kits together, we would provide materials.
 - BU MPH program is working on some currently.
- Fatal and Non-Fatal ODs this year
 - 18 suspected fatal overdoses
 - 19 suspected non-fatal know it is not the full picture. Drug supply is more stable.
 - John Barry: supply is toxic, not short-term toxic, but long-term toxic due to chemicals
 - Steven Cornejo: October has been quiet
- Contracted with a Public Health Public Safety Liaison, Chris Streno
 - Retired from law enforcement after 33 years
 - Regularly attended peer response meetings and is looking forward to starting that up
 - Will be providing harm reduction and stigma reduction education to public safety
 - Would like to hear what law enforcement can do better from groups here—email PHPSL@BroomCountyNY.gov
 - Will be expanding to fire and EMS as well
- CDC on furlough so we have no feedback, guidance, or contact about the OD2A grant.

5. Agency/group announcements/program updates

- Carmela Pirich (ACBC)
 - Always wonders about ODMAPS data as they have had 2 non-fatal overdoses in their waiting room and 1 in comfort center recently.
 - Unclear if public safety was called and if these should have been captured in ODMAPS
 - Let BCHD staff and Steven Cornejo know of date/time/location of known suspected overdoses so that we can crosscheck data.
 - BCHD staff is working to keep numbers updated; spoke at chief's meeting and dispatch to educate about ODMAPS
 - Seeing a lot more meth use than opioids
 - ACBC has been flooded with homelessness and overwhelmed with the difficulty of coordinating without a phone or address
 - Will be holding diaper and formula drives in the future
 - Don Garren: VOICES offered to be a drop-off location for diapers and formula
 - Rachel Leri: MBPN can provide ~15 diapers monthly. First Presbyterian Church in Binghamton has a diaper give away for one hour the first Wednesday of the month.

- Offering Mental Health First Aid, QPR, Talk Saves Lives, along with Narcan training for communities. If you have a group that wants training, reach out to RHN.
 - Mental Health First Aid is 8-hour training—1 day or 2 four-hour sessions
 - QPR: 60-90 minutes
 - Talk Saves Lives: 60-90 minutes
 - It's real (for teens): 90 minutes
- Steven Cornejo (Southern Tier Crime Analysis Center)
 - National Guard can also provide Narcan and has given to VPD and BPD
- Katie Medinosky (DSS)
 - Notified of ABAWD requirements changing
 - <https://otda.ny.gov/programs/snap/work-requirements.asp>
 - If anyone has mailings or basic work to be done, that could qualify as volunteer work
 - Someone engaged in drug and alcohol treatment can be exempt-including dosing
 - Concern for population who is older
 - DSS Naloxbox has been successful with plastic bags going faster
 - Kathy Staples: the blue bags are good for in person trainings, but plastic are popular everywhere else.
- John Barry (STAP)
 - has worked with RHN for MH fist aid--fantastic, easy to work with, encourage working with them for training.
 - Riverside Dr. food pantry--seeing 60 families/week
 - Cupboards are bare. Bare at CHOW also.
 - Occasionally have diapers, but call first
 - Also seeing overdoses. Veterinary drugs are doing a number on people, not the fatal effect of fentanyl, but long term toxicity
 - MK: Seeing that in drug testing too?
 - BTMPS-causes cardiac toxicity
 - Also seeing ppl using meth and Adderall
 - Uptick in HIV cases, started end of 2022. Normal 3-5/year in Broome. Last 12ish months, pushing up on 30.
 - Clinical work at your org, please push getting HIV test
 - Injection drug users and transactional sex work
 - Rural is a smaller pool of people
 - IVD users is small pool and can spread very quickly
- Don Garren and Murph Shea (VOICES)
 - 340 Prospect M-R: 9-8, F/S 9-5 with a homelike atmosphere
 - 2/week food
 - Clothes/1 week--also brings clothing to others--
 - Laundry 11 and 1 on Tuesdays 2x month
 - AA 3x week
 - NA 1x week
 - Provide bus passes and transport for those engaged with peer services
 - Peer services--Murph, Jess, and Sean to remove any barriers

- Nov. 16 bowling tournament @ Midway--all proceeds \$30/team--all goes to VOICES, Silent auction. Planning to use that money to purchase tents for the impending increase
- VOICES' favorite word is yes, always ready to help; can provide space for kits put together by DSS
- See their calendar pinned at the top of VOICES Facebook page
- Erica Robinson (Helio Health)
 - People have moved into Helio portion of housing on Court Street, other providers have not yet.
 - Helio has 30 units: single occupancy
 - Helio will always take referrals to fill an openings
 - Current and former OUD
 - Helio 30 units: single occupancy, own referral process, Kelly and Nick,
 - Helio will always take referrals to fill an openings
 - Current and former OUD
 - Housing Visions are property managers: and has final oversight of approval
 - Emotional support animals are allowed
 - Looking to have a housewarming party to welcome residents
 - Erica can show a vacant unit to those interested
 - Seeing lots of people coming in for detox from meth and cocaine
 - Working with VOICES to apply for foundation grant to get tents
- Kathy Staples (Truth Pharm)
 - 10/18--virtual raffle on Saturday and party in March
 - 10/27 potluck--family services, grief services,
 - 10/28 UHS Hep C testing
 - 11/3 STAP testing
 - Scheduling See Me Hear Me Treat Me for January with a focus on barriers of being unhoused and accessing harm reduction in medical offices.
 - Evidence based learning and include real life stories
- Mike Gazdik (BCDA)
 - NYS prosecutors handling drug crimes also report that fatal and non-fatal overdoses are trending significantly downward
 - Meth and cocaine use are up
 - Not seeing xylazine or nitazine as much yet
