Broome County Clerk Joseph Mihalko Re-Opens Endicott DMV Office

Broome County Clerk Joseph Mihalko is re-opening the Endicott DMV office effective Monday, June 15, 2020. The Endicott office will be open from 8:00 am – 4:30 pm, with the last transactions starting at 3:45 pm. The Endicott office will resume its normal Saturday hours starting June 20, 2020 from 8:00 am – 1:00 pm, with the last transactions starting at 12:45 pm. County Clerk Mihalko will be at the Endicott DMV on Monday, June 15, 2020.

Due to staffing limitations, the Binghamton DMV will not be reopening until Monday, June 22nd.

Our Satellite offices will remain closed until further notice.

Per instructions from the NYS DMV Commissioner, only transactions for Broome County residents will be processed.

Because New York State has not issued their official guidelines for re-opening and has not advised county operated DMVs what services can and cannot be offered through the NYS computer system, there are certain transactions that we cannot guarantee that will be available on Monday, June 15, 2020. These include Regular (Permit) License Exams, CDL (Permit) Exams, Enhanced Driver's License and REAL ID Transactions and Enforcements.

Since a large volume of traffic is expected, County Clerk Mihalko is asking customers to limit their transactions to only the most necessary and timely. "If your renewal isn't up for another month, we'd respectfully ask that you wait until the immediate rush has subsided," said Clerk Mihalko. "Many residents have been sitting on expired licenses and registrations since the State shut our DMVs down on March 21st, so we want to make sure those folks can get in and renew right away."

To accommodate as many Broome County residents as possible, the DMV offices will be extending their hours starting on Monday, July 6, 2020. During that week, both DMVs will be open from 8:00 am – 6:00 pm. Additionally, both the Endicott and Binghamton DMV offices will be open on Saturdays starting July 11, 2020 from 8:00 am – 1:00 pm, with the last transactions starting at 12:45 pm.

Those transactions which can be processed by mail can still be mailed to Binghamton DMV at 81 Chenango Street, Binghamton, NY 13901. The Clerk's secure DMV dropbox is mounted on the wall in the lobby of the Broome County Office Building, located at 60 Hawley Street in Binghamton. To avoid waiting in long line at the DMV, customers are strongly encouraged to continue handling their license plate returns and the vehicle registration renewals through the mail or our DMV drop box.
