

DO YOU NEED A COVID-19 TEST?

Below you will find COVID-19 testing locations and general testing information. We highly recommend you reach out to your or your child's primary doctor to schedule a virtual visit when you believe you've been exposed to COVID-19 or are experiencing symptoms. **Please remember emergency rooms should be reserved for medical emergencies.**

All testing locations require you to provide your own transportation. Testing time frames are not guaranteed and can change due to high frequency of testing

Symptomatic: COVID-19 testing for symptomatic individuals may be completed via antigen or PCR testing. When possible, individuals should utilize their primary care provider for a physician referral for testing. In the absence of a primary care provider, alternative testing options should be used.

Asymptomatic: Antigen/PCR testing options may be utilized for asymptomatic individuals who have been exposed to a confirmed COVID-19 case or for population surveillance, otherwise known as "screening testing." Post-exposure testing should be performed 3-5 days after the last known contact with a confirmed case.

Testing After COVID-19 Exposure: In accordance with the CDC, fully vaccinated individuals who are exposed to a confirmed case of COVID-19 do not need to quarantine or test unless they become symptomatic.

PCR Testing: PCR testing is sufficient to confirm both positive and negative cases. ONLY a negative PCR test may be utilized to allow for return to school. Negative antigen tests are not sufficient for returning to the classroom.

Home Tests: While home tests are a useful tool to identify positive cases, a negative home test is not acceptable for purposes of surveillance testing or discontinuation of quarantine. A positive home test will be considered a confirmed COVID-19 case and must be reported to Broome County Health Department plus, workplaces or school nurses as applicable. A positive case should also be reported to the school district, when applicable.
