LLC to allow them to perform necessary studies including all necessary environmental reviews prior to entering into a lease for the parcel, now therefore, be it RESOLVED, that the County Legislature authorizes an agreement with Above Grid Solar, LLC to perform all necessary studies including all necessary environmental reviews in order to complete their due diligence prior to approval of a lease agreement by the County Legislature, and be it FURTHER RESOLVED, that the County Executive or his duly authorized representative it hereby authorized to execute any such agreements, documents or papers, approved as to form by the Department of Law, as may be necessary to implement the intent and purpose of this Resolution."
