Newcomb stated they have 15 Deputies trained in mental health services and also use MHAST for additional professional services. Mrs. Ryan stated she would like to see detailed goals listed in the Plan and receive periodic updates. Several Legislators thanked Deputy County Executive McManus, Sheriff Harder, Public Defender Baker and the rest of the Panel members for their efforts. Carried. Ayes-5, Nays-0
