WHEREAS, the Director of Public Health requests authorization for a Memorandum of Understanding agreement with the New York State Department of Health for the Broome County Health Department (BCHD) to participate in the 340B Drug Pricing Program for STD Medication for the period March 1, 2026 through February 28, 2027, and

WHEREAS, the Broome County Health Department STI clinic serves as a safety net that supports prevention, testing and treatment efforts in a high-morbidity population. The 340B Drug Pricing Program for STD Medication allows eligible participants to purchase drugs at a decreased cost, now, therefore, be it

MEMORANDUM OF AGREEMENT

By and Between the

***County of Broome
(hereinafter referred to as the "County")***

and the

***Broome County Local 804 Unit 6150,
Civil Service Employees Association, Inc.
(hereinafter referred to as the "Union")***

WHEREAS, the County and the Union are parties to a Collective Bargaining Agreement for a term which expires on December 31, 2024; and

WHEREAS, the County and the Union have been engaged in collective bargaining, which has led to a mutual understanding between the County and the Union for the terms and conditions of employment for a Successor Agreement; and

WHEREAS, the County and the Union are desirous of reducing that mutual understanding to a written document.

NOW, THEREFORE, the County and the Union agree to amend the Collective Bargaining Agreement as follows:

1. All terms and conditions of the existing Collective Bargaining Agreement shall continue in full force and effect unless specifically modified by this Memorandum of Agreement and/or the terms of the expiring Agreement.
2. This Memorandum of Agreement is subject to ratification by the membership of the Union and by the County Legislature.
3. The County and the Union agree to remove all obsolete language from the current Agreement. The County will provide the Union with a Microsoft word document with obsolete language stricken out for the Union's review and approval.
4. All changes proposed herein shall become effective as of January 1, 2026, unless otherwise indicated.

5. **ARTICLE 9, COMPENSATION**, shall be amended to read as follows:

1. Effective January 1, 2026, full-time and part-time employees shall receive a general wage increase of 3.0%.
2. Effective January 1, 2027, full-time and part-time employees shall receive a general wage increase of 3.5% to their base wage.
3. Effective January 1, 2028, full-time and part-time employees shall receive a general wage increase of 3.5% to their base wage.
4. Effective January 1, 2029, full-time and part-time employees shall receive a general wage increase of 3.5% to their base wage.

Minimum salaries on the CSEA schedule will increase in 2026, 2027, 2028, 2029 by the same amount as the wage increase listed above for that year.

The Salary Schedule, pay grades, and titles shall be attached as Exhibit A at the end of the Collective Bargaining Agreement.

Retroactivity shall be paid to all current employees and retirees that retired on or after 1/1/26.

All employees will be paid via direct deposit only. Employees, upon request, shall be furnished with a printed pay stub.

6. **ARTICLE 9, PERFORMANCE INCREMENTS**, shall be amended to read as follows:

5. **PERFORMANCE INCREMENTS**

Each employee who is at step 4 or below shall receive a performance increment (Step increments= 3% of the base minimum hourly rate up to and including Step 5) on his/her anniversary date in title, provided that he/she has received a satisfactory performance evaluation. For the purposes of this salary plan, the term "anniversary date in title" (current title or grade) shall mean the day upon which the employee assumed the duties and responsibilities of a particular title, whether on a temporary, provisional, probationary or permanent basis, unless the assumption of the particular title is in the same pay grade as the employee's previous title as reflected in the records of the Department of Personnel.

7. **ARTICLE 19, HOLIDAYS**, shall be amended at paragraph 1 by adding Juneteenth.

8. **ARTICLE 14 – LEAVE FOR CSEA MEETINGS**, the first two paragraphs shall be amended to read as follows:

Leave will be granted to any CSEA member to attend regional and statewide meetings of the Civil Service Employees Association without loss of pay. The leave granted herein shall not exceed a total of sixty-four (64) employee days per year for all employees covered by this Agreement to attend such regional and statewide meetings. Written notice for such leave, certified to by the President of CSEA, must be presented to the department head, with a copy to the Personnel Officer, at least five (5) working days prior to the requested leave time. The sixty-four (64) days herein provided to attend CSEA conferences or meetings shall include travel time.

The President of the Broome County Unit of CSEA will be allowed a reasonable amount of leave with pay away from his/her regular duties in order to attend conferences and meetings of CSEA and to handle the CSEA business of the employees covered by this Agreement. If the President is unable to perform his/her duties, the Broome County Unit of CSEA may designate another representative to act in place of the President by giving written notice to the Public Employer. Leave for the President to attend CSEA conferences is not to be deducted from the total of sixty-four (64) employee days as hereinabove provided. Reasonable notice to supervision must be made by the union official before union time off shall be allowed.

9. **ARTICLE 27 – LONGEVITY SERVICE PAY**, paragraph A will be amended to read as follows:

Effective 1/1/2026, Full-time employees hired after January 21, 2016, shall be paid longevity service payments upon completion of the years of service outlined in **Schedule A** below.

Effective 1/1/2026, Full-time employees hired before January 21, 2016, shall be paid longevity service payments upon completion of the years of service outlined in **Schedule B** below.

Subparagraph 2 in paragraph B will be deleted.

10. **ARTICLE 18 – OVERTIME, EXTRA HELP AND NIGHT RATES OF PAY**, shall be amended by adding the following before paragraph 1a):

Departments that have at least one full 1st shift and one full 2nd shift will be required to pay shift pay. Shifts will comply with the following guidelines: 1st Shift will be defined as a morning shift, 2nd Shift will be defined as an afternoon shift, and 3rd Shift will be defined as the overnight shift. Each Department will be responsible for defining those shifts and reporting them to the Personnel department to have on file

Effective January 1, 2027, paragraph 1h) shall be amended to read as follows:

- 1h) If the employee is regularly scheduled for 2nd shift, they shall be paid one dollar (\$1.00) per hour shift differential.

Effective January 1, 2027 paragraph 1i) shall be amended as follows:

- 1i) If the employee is regularly scheduled for 3rd shift, they shall be paid eighty-five cents (\$0.85) per hour shift differential.

Effective January 1, 2027, paragraph 1j) shall be amended as follows:

- 1j) At Will Point Nursing Home only the following differentials apply:

Nursing Assistant	\$1.00/hr.	2 nd shift
	\$0.90/hr.	3 rd shift

Nurses (LPN, SLPN, RPN, SRPH, Charge Nurse)		
	\$1.45/hr.	2 nd shift

Staff Assigned to Supervisory duties on weekends and holidays (in accordance with Article 18, Section 1(g) and Article 19) shall receive a stipend of \$3.00/hr. for all hours worked in this capacity. This stipend will be paid on the actual holiday and not on the observed (Friday or Monday) holiday.

In departments where employees work a schedule consisting of 4 days on and 2 days off the following shall apply:

- 1) Where an employee's regular schedule does not require he or she to work the actual holiday, the employee shall receive no additional compensation for the holiday.
- 2) Where an employee's regular schedule requires the employee to work the actual holiday he or she shall receive an additional days pay.

11. ARTICLE 18, OVERTIME, EXTRA HELP AND NIGHT RATES OF PAY,

paragraphs 1c) and 1d) shall be amended to read as follows;

- 1c) Departments may offer compensatory time in lieu of overtime pay. Where the Department Head offers compensatory time, the employee shall accrue paid time off at the rate of time and one-half for all work performed in excess of 37 1/2 hours per week or 40 hours per week, depending on the person's regular work schedule.
- 1d) Effective 1/1/26, compensatory time accrued by the section above shall be taken within 240 calendar days of accrual. Any compensatory time not used within 240 calendar days will be paid out in the next payroll period. Requests to use compensatory time will be treated the same as any other paid time off and will be subject to approval by the Department head and/or Supervisor.

12. ARTICLE 18, OVERTIME, EXTRA HELP AND NIGHT RATES OF PAY,

the first paragraph of section 6a) which currently reads "On-call pay shall be established in order to provide 24 hours coverage where necessary. Employees required to be on-call shall be paid at a rate equivalent to \$20/day for on-call status" shall be amended to read as follows:

On-call pay shall be established in order to provide twenty-four (24) hour coverage where necessary. Employees required to be on-call shall be paid at the following rates per day for on call status. Employees **called in** (leave their residence and respond to a County location) shall receive a minimum of 4 hours of pay if called in.

13. ARTICLE 17, BASIC WORK WEEK, Section 8, Shift Bidding -

Department of Emergency Services shall be amended to read as follows:

- A. Shift bidding shall take place twice a year to determine the dispatchers shift preference. Bids will take place in January for the period March through August and in July for the period September through February. The bids shall be according to Seniority in Classification. Shift assignments will be made taking into account the dispatchers shift preference and Departmental seniority whenever possible, but the department's needs for proper staffing will be the first consideration.

Shift bidding shall take place twice annually; once in December for the period of March through August, and again in June for the period of September through February.

- B. Seniority in Classification will be determined based on the following criteria:
1. Date of hire as a full-time Emergency Services Dispatcher with Broome County.
 2. A two-month credit will be given for each full year and a one month. credit will be given for each partial year of part-time Emergency Services Dispatcher service with Broome County.
 3. In the event two dispatchers have the same hire date, then their civil service list position will be used for determination. If no civil service test exists it will be by application date.
 4. Dispatchers transferred from the City of Binghamton will have seniority from their date of hire as a dispatcher with the City of Binghamton.
- C. Dispatchers may request to change shifts during a period by submitting a written request signed by both dispatchers who want to switch shifts to the Communications.

14. **ARTICLE 20, VACATION**, paragraph II, Vacation Bidding – Department of Emergency Services, shall be amended to read as follows:

Vacation bidding for Emergency Services will occur twice a year. The first bidding period runs from January 1 to January 15 and covers only the months of March to August. The second bidding period takes place from July 1 to July 15 and is for only the months of September to February. (February 29 on leap years).

1. The bids shall be according to seniority in classification.
2. Employees may pass during the first bid period but must make their selection by the second bid period, or they shall forfeit their remaining vacation, except for carryover as described in their union contract.
3. Bids shall be in blocks of 4 days. The number of required blocks to bid shall depend on accrued days:

< 5 total days:	No blocks required
5-9 total days:	1 block required
10-16 total days:	2 blocks required
>16 total days:	3 blocks required

4. Employees who bid vacation time and are approved for such vacation are not responsible for finding their own coverage for vacation days, **on calls etc.**

15. **ARTICLE 17, BASIC WORK WEEK**, paragraph 3 and paragraph 3.a shall be amended to read as follows:

3. Where the Department Head deems it necessary to alter the work schedule due to the need to maintain and operate the department, the following procedures shall apply:
 - a. Employees will receive at least fifteen (15) working days' notice prior to any schedule changes.

16. **ARTICLE 42, UNIFORMS.**

Effective January 1, 2028, paragraph 2 shall be amended to read as follows:

Where a uniform is required and not supplied by the County, the following shall be effective January 1, 2028.

- Full-time Employees shall be paid a uniform allowance of \$400 per year.
- Part-time Employees shall be paid a uniform allowance of \$250 per year.
- Full-time employees *who are* required to wear boots, based on the work performed, shall receive a boot allowance of \$250
- Part-time employees who are required to wear boots, based on the work performed, shall receive a boot allowance of \$125
- Full-time Employees who are required to wear specific safety footwear shall be paid a footwear allowance of \$200
- Part-time Employees who are required to wear specific safety footwear shall be paid a footwear allowance of \$100

All allowances will be paid annually in January.

In Departments where uniforms are provided to employees, the County will be responsible for replacing or exchanging improperly sized items.

17. **ARTICLE 34, LABOR MANAGEMENT COMMITTEE**, paragraph 1 shall be amended to read as follows:

1. The County and the Union shall establish a Countywide Labor-Management Committee comprised of two (2) representatives from the County, at least three (3) members from the Union, and one (1) additional member assigned to document the meetings. The purpose of this Committee is to engage in discussions and seek solutions to workplace issues and inequities, addressing both immediate concerns and future challenges. Representatives from individual Departments, as necessary, may be required to attend meetings when specific departmental issues are presented. The Committee shall convene on a monthly basis to ensure ongoing dialogue and collaboration between labor and management for the betterment of the workplace environment.

18. **ARTICLE 41, MANDATORY PHYSICAL EXAMINATION,** shall be amended to read as follows:

Where a physical examination is required of an employee by the County, other than the initial employment physical, the employee shall have the right to have a doctor of his/her choice perform the same and the County shall be liable for the cost of the examination

The County, however, reserves to itself the right to required examinations by doctors of the County's choice for purposes associated with determinations as to mental and physical capacity to perform employment duties, disciplinary actions, workers' compensation cases or for similar purposes.

19. A new ARTICLE will be added to the Collective Bargaining Agreement entitled "WILLOW POINT STAR DAY," which shall read as follows and all other references currently in other articles relating to the Star Day will be removed:

It is the policy of Willow Point Rehabilitation and Nursing Center to award one Star Day every 4 weeks in lieu of Holidays for Full-time and Part-time Employees. CSEA employees who work a Star Day Schedule and meet attendance criteria will be covered under the following procedures:

1. A Star day Schedule is an alternating weekend schedule for full time and part time employees in the following positions.
2. Floor Nurses, Certified Nursing Assistants, Custodial workers, Laundry Workers
3. Full-time Star days are based on an employees work performed of their regular full-time work shift of either 7.5 hours or 8 hours. Part time star days are paid at 4.0 or 3.75 hours based on employees scheduled hours.
4. Eligibility is determined every 4 weeks and is awarded to employees who have fulfilled working all scheduled work days. Full time and part time employees must work the day before and after the Star Day unless authorized leave is approved.

5. Full-time Star Days are paid/scheduled off every 4 weeks based on the Group Number each employee is put into. Generally Star Days are scheduled on Mondays for 1st and 2nd shift and Sundays for 3rd shift. Star Days are typically scheduled to provide an employee a long weekend (3 day) -or a Monday and Tuesday Off.
6. Star days can be rescheduled for a different weekday off as approved by their Supervisor or Scheduling Office.
7. Employees are eligible to receive their Star Day once the start working in a group. If the group is changed a review will be done to ensure only 1 Star Day is received.
8. The total time off equals 13 days and 2 floating holidays equal to 15 paid time off days in a year to coincide with the CSEA holiday Time off for Monday through Friday/Non-Star Day employees.
9. Department managers are responsible for authorizing Star Days and communicating changes with the Payroll Department via a PCN.

HOLIDAY HALF

If worked Star Day Employees are paid Holiday Half for Holidays listed in the CSEA contract in Article 18 Section 1(g). All other benefits are paid in accordance with the CSEA collective bargaining agreement.

Nursing home employees who work a star day schedule shall have their overtime calculated on the basis of work performed over eight (8) hours in a work day, or over eighty (80) hours in a fourteen (14) calendar day pay period. All other nursing home personnel shall have overtime calculated as outlined above.

1. All nursing home personnel who work a star day schedule shall be paid time and one-half for all hours worked on the following holidays: New Year's Day, Lincoln's Birthday or Washington's Birthday as provided herein, Memorial Day, Juneteenth, Independence Day, Labor Day, Columbus Day, Veteran's Day, Thanksgiving Day and Christmas Day. Lincoln's Birthday shall be observed as a premium holiday in even-numbered years, and Washington's Birthday shall be observed as premium holiday in odd-numbered years. In the event New Year's Day, Independence Day, Veteran's Day or Christmas Day fall on a Saturday or Sunday time and one-half will be paid on the actual holiday and not on the observed (Friday or Monday) holiday. The present star day procedure will continue in effect. All nursing home personnel who do not work a star day schedule will receive holidays as provided by Article 19 of this agreement.
2. Nursing home Employees. Nursing Home employees shall not be required to work Christmas Day, New Year's Day, Thanksgiving Day and the 4th of July in two (2) consecutive years.
3. The holiday policies at Willow Point Nursing Home as of January 1, 1981, with the exception of paragraph 5, shall remain in full force and effect.

WEEKEND SUPERVISORY STATUS

Staff Assigned to Supervisory duties on weekends and holidays (in accordance with Article 18, Section 1(g) and Article 19) shall receive a stipend of \$3.00/hr. for all hours

worked in this capacity. This stipend will be paid on the actual holiday and not on the observed (Friday or Monday) holiday.

20. **ARTICLE 10 – PARKING FEES**, shall be amended by deleting the second paragraph.

21. **ARTICLE 18, OVERTIME, EXTRA HELP AND NIGHT RATES OF PAY**, shall be amended at paragraph 1 (f) by deleting “Central Foods” and “Nutrition Services Department.”

22. **ARTICLE 28, PENSIONS**, shall be amended to read as follows:

The County agrees to provide plan 75(i) coverage for all employees covered by this Agreement who are eligible for that plan under the New York State Retirement and Social Security Law.

All employees covered under this Agreement shall be eligible to receive the benefits of Section 41(j) (conversion of unused sick leave benefits) as provided by law. The entire premium for this benefit shall be paid by the Employer.

23. **ARTICLE 39 – EMPLOYEE LISTING**, paragraph 2 shall be amended to read as follows:

On the effective date of this agreement, the employer shall supply the CSEA Unit #6150 a list of all employees in the bargaining unit showing the employees’ full name, home address, job title, department and work location, and CSEA insurance programs deductions. Such information shall thereafter be provided to the CSEA Unit #6150 upon request of CSEA, but no more than quarterly.

24. **ARTICLE 48, DRUG AND ALCOHOL TESTING** shall be amended to read as follows:

All employees of the Security Department, and Probation Department employees who are authorized to carry a firearm, shall be subject to the same drug and alcohol policy as the Broome County Sheriff's Department. Current language that requires all Security employees to be tested remains unchanged.

25. **ARTICLE 13 – ASSIGNMENTS** shall be amended by adding a new paragraph to be paragraph 4 to read as follows:

4. **Security Assignments and Canine Notes Assignments:**

All present assignments which include, but are not limited to the following, shall be at the complete discretion of the Director of Security:

1. Training Committee
2. Security Gov Com
3. Community Engagement
4. Park Officers
5. K-9

Should the Director of Security decide to create a new assignment expected to exceed **ninety (90)** days and is not listed above, he/she shall notify the CSEA President ten (10) workdays (except in an emergency) prior to any assignment being filled, and such assignment shall be amended to the present list. Further, if a new assignment opportunity occurs, the Director of Security shall post such opportunity for a period of fourteen (14) calendar days. The Director of Security shall select, at his/her discretion, from those employees who have applied in writing to fill the assignment. The Director of Security's decision shall be non-arbitrable.

Canine Notes:

- A. Security K-9 Officer(s) will be paid from their scheduled start time to their scheduled end time.
- B. All K-9 Officers are authorized to sign in service from their home and out of service one-half (1/2) hour prior to the official end of their shift to perform K-9 care duties.
- C. All K-9 Officers will be assigned a vehicle to transport their canine partner to and from work.
- D. All K-9 Officers will be utilized in an On-Call capacity at the complete discretion of the Director of Security or his/her designee.
- E. All K-9 Officers shall have their canine partner out of the vehicle for a minimum of two (2) hours during their scheduled shift, completing functions best served by a canine.
- F. All K-9 Officers will receive one (1) "floating day" off per quarter to be used in the calendar year. Such day cannot be carried over and will be lost if not used prior to the end of the year.
- G. All K-9 Officers shall receive a stipend of \$100 per month for the care of their canine partners for when they are off duty.
- H. While the K-9 is owned by the County, the County shall be responsible for all veterinary costs, including the cost of boarding the K-9 while the K-9 officer is on vacation.

26. **ARTICLE 24, HEALTH INSURANCE**, the first sentence of paragraph 1 shall be amended to read as follows:

The County agrees to continue and maintain a health insurance program which provides benefits equivalent to the health insurance plan in effect on January 1, 2026.

27. **ARTICLE 36, PERSONNEL FILE**, paragraph 1 shall be amended to read as follows:

1. The employee shall notify the Department of Personnel at least 10 days in advance that he or she desires to review their personnel file. Such review will be conducted in the Department of Personnel. The material in the employee's personnel file will not be allowed to be taken out of the Personnel Department. If copies of the material are desired, said request will be made at the time of review, an employee may enter into the personnel file any statements relating to material covered in the file.
