It was stated that before the County takes a property in the in-rem foreclosure process, the property owner has the option to enter into an installment agreement and no title search fee is applied. It was further stated that the County must make municipalities whole on delinguent taxes and can no longer keep any surplus from the sale of in-rem foreclosures, which leaves the County with a deficit. The State created new guidelines for the in-rem foreclosure process which allows a title search fee to be added to the taxes owed. In most cases, the fee would be paid from excess proceeds returned to the property former owners.
