#47 RESOLUTION ADOPTING LOCAL LAW INTRO. NO. 10 OF 2019, ENACTING THE "EMERGENCY FIRST RESPONDERS PROTECTION ACT OF 2019"

Mr. Whalen questioned the use of the word "annoying". Mr. Behnke stated that it is not an improper use of the word and it is used in State Law to define harassment. Mrs. Kaminsky thought this was already a law. Mr. Behnke stated this enhances the penalty of harassment under penal law. Responding to a question from Mrs. Myers, Mr. Baker stated that its important to adopt this law because it has been shown that there is an increase of incidents of harassment against first responders. Mr. Reynolds stated that this is consistent with State law and it is another tool that can be used to deter persons from interfering with the duties of first responders and covers first responders that are not part of a governmental unit. It is not intended to interfere with freedom of speech.

#48 RESOLUTION URGING THE ADOPTION OF SENATE BILL S.335 (AKSHAR) AND ASSEMBLY BILL A.5065 (ABBATE) A/K/A THE "COMMUNITY HEROES PROTECTION ACT"

Mrs. Kaminsky sighted the definition of a hate crime and doesn't understand how this fits. Mr. Reynolds stated that the Legislature passed a similar Resolution in 2017 and it seeks to change the NY State law to accommodate these individuals from being targeted because they are wearing uniforms. Mrs. Myers questioned the intent of the bill and it was suggested that she check with Senator Akshar or Assemblywoman Lupardo. Carried. Ayes-4, Nays-1 (Kaminsky)
