Answering a question from Mr. Whalen, Mr. Holdrege stated that since April 2020 CBH Medical owes/would have owed \$302,000 in minimum staffing penalties. He further stated that there has been a request to waive those penalties dating back to that time period. Mr. O'Donnell stated that this Resolution before the Committee would only waive the fees for January 1, 2021 through March 31, 2021. Answering a question from Mr. Baker, Mr. Holdrege stated that the County Executive waived the fees for 2020 through either an executive order or emergency order in consultation with the Law Department. Mr. Pasquale asked if it was done that way in 2020, why is the Resolution necessary for 2021. Mr. Reynolds also asked who has the authority to modify or change this contract and whether or not that executive or emergency order was still in effect. Mr. Martin stated that a copy of the executive or emergency order had been requested but had not yet been received. With several questions remaining outstanding, Mr. Pasquale made a motion, seconded by Mr. Weslar to table the Resolution to a date uncertain so the Legislature could obtain further information from the Sheriff and Law Department.
