Mrs. Beebe expressed displeasure with raising the minimum landfill tipping fee per weighed vehicle from \$5 to \$10. She also expressed concerns with how the raising of the per ton fee from \$45 to \$55 for commercial and municipal haulers will impact residents as she believes the cost will be passed on to them.

Mr. Pasquale stated that this Local Law will be held over to the Special Budget Session and will be further discussed at that time as part of the overall 2022 County Budget. Carried. Ayes-5, Nays-0

Following the Resolutions, Mrs. Boulton stated that next month in November the Committee will undertake consultant interviews for a County bridge project. The bridge in question is the Colesville Road Extension Bridge over the Susquehanna River between Colesville Road and Conklin Road. She further stated that the prequalified list for this project will include Delta Engineers, McFarland Johnson, C&S Companies, Barton & Loguidice, and Greenman Pedersen.

There being no further business to come before the Committee at this time, a motion to adjourn was made by Mr. Baker, seconded by Mr. Whalen. The meeting adjourned at 4:31 PM.
