- Note 1: All **budget review meetings** will be held in the Large Legislative Conference Room, 6<sup>th</sup> floor, Edwin L. Crawford County Office Building, 60 Hawley Street, Binghamton.
- Note 2: Times are subject to change based on length of prior sessions. With the exception of the first Department scheduled, Department heads are asked to be available 30 minutes prior to their scheduled start time. Members of the Prime Committee are encouraged to attend.

- Note 5: Broome County Budget Timeline is as follows:
- **Thursday, September 12<sup>th</sup> at 6:00 p.m.** the County Executive presented his recommended budget.
  - Finance Committee Budget Review as attached.
  - **Thursday, October 24<sup>th</sup> at 5:00 p.m.** the Legislature will hold a Public Hearing on the County Executive's 2025 Recommended Budget.
  - **Thursday, November 7<sup>th</sup> at 4:30 p.m.** Special Finance Committee meeting to formulate and approve Finance Budget Amendments Report.
  - **Thursday, November 7<sup>th</sup> at 5:00 p.m.** Special Session to consider the Finance Committee's Budget Amendments Report and consider other budget amendments and budget Resolutions.
  - By November 14<sup>th</sup> A Public Hearing will be held by the County Executive on any items the Legislature approved to strike, reduce or increase from the proposed 2025 budget.
  - November 15<sup>th</sup>. Last day for the Legislature to present changes to the County Executive budget.
  - November 19<sup>th</sup> Last day for the County Executive to submit objections (vetoes) to the Legislature.
  - November 25<sup>th</sup> Last day for the Legislature to meet to consider vetoes.
  - November 27<sup>th</sup> Budget deemed adopted if the Legislature fails to act on or override the County Executive's vetoes.
