Subject:

Potential Pause of Federal Funds

Considering recent developments at the federal level, I'm providing an overview of the potential "pausing" of federal revenues by function area and department. It is important to note that the assumption is that no federal funds already disbursed to the County will be subject to a takeback. Medicaid, Medicare, and SNAP (Supplemental Nutrition Assistance Program) direct funds were excluded from the potential "pause" and are not accounted for below. The potential freezing of federal revenues presents significant challenges for our County across many departments. Within these departments federal funding provides partial to full salary and benefit support for a minimum of 433 positions. The current estimate of federal funding that could potentially be affected is \$142.059.537.

This memo aims to delineate which departments may be affected and the impacts on their operations.

Health and Human Services:

Health Department

Federal monies in the amount of \$3,126,700 are budgeted for direct food dollars a major part of the Women, Infants, and Children's program in 2025. The Health Department currently has thirteen grants supported by federal funds. These grant revenue budgets total \$9.6M, of which approximately \$345k has been spent and not yet reimbursed. These grants support 27.6425 Full Time Equivalents (FTE).

Office for Aging

The Office for Aging currently has eight grants and almost 30 FTEs supported by federal funds. Claims are in process for \$866,142, \$70,000 has not been expended yet and we are waiting for \$36,655 to be reimbursed.

Total Office for Aging is approximately \$972,797.

Department of Social Services

The Department of Social Services has outstanding Federal Receivables of approximately \$19M related to the 2023 and 2024 fiscal years.

Over 360 FTEs within the department are partially funded by Federal dollars.

In the department's 2025 operating budget approximately \$12M is estimated in federal funding to support the administration of the following programs. Federal reimbursement varies by program with remaining amounts being paid by NYS and/or Broome County.

Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF), Child Support Enforcement, Guardianship Assistance, Promoting Safe and Stable Families, Child Welfare, Independent Living, State Children's Health Insurance Plan (SCHIP), Medical Assistance, Foster Care, Adoption Assistance, and Title XX Social Services Block Grant (SSBG).

\$21.1M is estimated revenue for 2025 to cover program costs. The Federal reimbursement varies by program with the remaining amount paid by NYS and/or Broome County. Temporary Assistance for Needy Families is budgeted at \$8.4M and is 100% Federally funded. The following programs make up the remaining \$12.7M.

Child Welfare, Foster Care, Adoption Assistance, Medical Assistance, Title XX Social Services Block Grant (SSBG), Refugee and Entrant Assistance Program, Emergency Assistance for Families with Children (EAF), Domestic Violence services, Independent Living, and Guardianship Assistance.

The Department of Social Services currently has ten different program grants with federal funding not yet claimed of approximately \$14M. \$10M of which is for Child Care and Development Block Grant.

Total Department of Social Services is approximately \$66,414,217.

Veterans Services Agency

Currently the Veterans Resource Center – Tiny Homes capital project is anticipating \$1.5M in Federal funds.

Total Veterans Service Agency is \$1,500,000.

Public Works and Transportation:

The County receives substantial federal funding for infrastructure projects, including at the airport, public transit, and bridge repairs. Binghamton Metropolitan Transportation Study (BMTS) is 100% federally funded.

Aviation

The following current projects have a Federal Revenue component.

The Terminal Project has \$4.3M in expenditures waiting to be reimbursed with an additional \$4M not yet requested for reimbursement.

The EMAS Construction Project is 90% complete and not yet reimbursed in the amount of \$1,440,016.

Taxiway A Construction Project is set to start in June 2025 with 85% of the total project being Federally funded at approximately \$4,712,000.

Snow removal equipment has been ordered at a cost of over \$1M. Federal contribution is 90% or approximately \$1,030,000.

Total Aviation is approximately \$15,482,016.

Public Transit

Federal Funding for Public Transit allocated supports both regular operations, approximately \$5M each year, as well as fleet replacement, approximately \$1M each year.

The total estimated Federal Aid for these Public Works projects is \$10,990,411.

Binghamton Metropolitan Transportation Study (BMTS)

Federal reimbursement has been requested, but not yet received in the amount of \$589,729 for 2024-25 fiscal year.

The estimated Federal revenue for the 2025-26 fiscal year is \$980,791 and supports 5 FTEs.

BMTS has one grant, Safe Streets & Roads, which is supported 80% or \$478,400 by Federal funds.

Total BMTS is approximately \$2,048,920.

Public Safety and Emergency Services:

Federal support for public safety, through grants and funding for law enforcement, emergency services, and crime prevention programs.

Sheriff's Office

The Sheriff's Office currently has 13 open grants. These grants are in various stages of spend down and reimbursement requests. The COPS Hiring Program supports 4 FTEs.

The Office of Emergency Services currently has four grants with Federal funding and supports 1.5 FTEs.

Each year the Probation Department receives Federal revenue for the Ignition Interlock Device Monitoring Program.

Total for Probation is approximately \$8,033.

District Attorney's Office

Estimated Federal revenue is included in the 2025 budget for the DA's Office to reimburse 0.3 of a Senior District Attorney's salary.

Total for District Attorney's Office is approximately \$46,525.

Economic Development, Education, and Culture:

Department of Planning and Economic Development

This department currently has three grant projects in which federal reimbursement has not yet been requested.

Included in the 2025 Capital Improvement Plan for SUNY Broome is the \$4.6M Decker Health Science Renovation Phase V. Estimated Federal funding for this project is \$200,000.

Office of Employment and Training

This Office receives Federal funding both directly and as a pass-through from NYS. A major of the funding through the Workforce Investment Act has been allocated and received by NYS. Currently there are several other special grants that may be affected which include almost 5 FTEs.
