Re: Public Safety Radio System Update

### **Overview**

As I noted in January the project was delayed by COVID-19 in 2020 significantly. Since my last report I am happy to report we have made some headway. We have won our court case to bring power to the Laurel Lake site, thanks to Mr. Behnke. Our construction contractor has been making great progress on the last remaining sites. Public works has started construction on the second to last road.

The concerns related to system cutover still remain and are too far out to identify if we will make the key deadlines to cutover in fall of 2021 or sprint of 2022. Where we anticipated launching the system at some point in 2021 that is now looking like it will be 2022. We anticipate missing key deadlines related to system acceptance before fall of 2021. In particular we are concerned about testing the system before the leaves are off the trees. Testing is required to be completed with leaves on because of RF penetration and behavior.

### Physical Infrastructure

Work is progressing on the physical sites for the radio upgrade project. Please see the attached Site Development Checklist. We are currently building: Lisle, Maine, and Windsor. Kirkwood and Deposit will be released as soon as possible.

## Sites:

We are in process of procuring via property acquisition or lease agreement the following sites to build out the system:

- Lisle (Town of Lisle): Construction underway estimated completion end of March.
- Maine (Town of Maine): Construction underway estimated completion early April.
- Kirkwood (Town of Kirkwood): DPW has approval to start road construction and site clearing.
   Will be released to tower construction company as soon as possible.
- Ely Park (City of Binghamton): Complete
- Nabinger (Colesville): Complete
- Sanford (Town of Sanford): Complete
- Deposit (Town of Sanford): County attorney working on lease agreement with property owner.

- Laurel Lake (Town of Sanford): Construction complete Eminent domain process completed, related to NYSEG to connect power. Site commissioning to be completed as soon as site is energized.
- Windsor (Town of Windsor): Construction underway estimated completion mid-April.

All 16 sites are ready for electrical work by DPW to power the Motorola equipment at each site. It is anticipated to be completed in the first quarter of 2021.

## Requests for Proposals

- Construction The last construction RFP has been awarded to Patriot Towers out of Scottsville NY. This covers the five remaining tower sites. We have released for construction Maine, Windsor, & Lisle. Kirkwood will be released shortly.
- Steel Lattice Towers and Shelters Delivery to each site is scheduled by the contractor.
   Significant delays in tower and shelter procurement have delayed the project. From our understanding these delays are based on raw material availability to the vendor. In the last month we have also been notified by the vendor they are requesting Broome County compensate them for the increase in steel costs on the last two tower sites. We are in negotiations on this.
- Generators (cooperative purchase) delivery of 5 remaining generators in mid-March.

#### **Road Construction**

The highway department has been an instrumental partner in constructing the roads to each of these sites. The road at the Kirkwood has been released to DPW and expected to start the week of 3/15. The deposit road will be released for construction as soon as possible.

### Microwave

Aviat has been contracted to install microwave connectivity to the nine new towers. Purchase Order has been issued. Engineering work is underway. This process will take approximately 3-4 months.

We expect to receive the equipment this week for the Public Safety to Ely Park connection. This will be installed within the next month.

## Motorola Contract

- Frequency licenses are now complete.
- System design is finalized.
- OES staff have been designing preliminary talk path profiles for the end user initial discussions have started on talk path design.
- Motorola Lease agreement has been singed.
- First shipment of Motorola infrastructure equipment has been received and distributed to the tower sites.

We have been diligently meeting with all agencies that we dispatch for (approximately 55) and validating their subscriber unit numbers. This entails reviewing mobiles, portables, and control stations. While we based our initial allocation on a formula that doesn't cover the nuances of each individual department. We anticipate finalizing our approximately 4000 subscriber unit order with Motorola in April.

We anticipate Motorola starting to install infrastructure equipment in late Spring 2021.

### 911 Center Related Upgrades

In preparation for the new radio system we will be upgrading infrastructure in the 911 center to make it compatible with the new system.

Vesta 911 Phone upgrade is now scheduled to be completed in Q3 of 2021.

Similarly, our 911 log recorder is being replaced to allow for digital frequencies to be recorded. This project is currently underway, physical hardware has been installed, software configuration is in progress.

Zetron (radio console) upgrade was able to be completed in 2020.

## <u>Other</u>

We have begun the process of quoting fiber connectivity to Onondaga County to interface with their radio core.

A Master Site Agreement with Onondaga is currently under review and will be brought to the legislature in the next several months.

MOU's with neighboring county's for use of their microwave systems should be expected in the next few months.
