## MEDIA RELEASE

The Broome County Sheriff's Office made the following arrest yesterday:

On Wednesday, January 12, 2022 at about 4:00 pm deputies responded to a business located on State Route 369 in Port Crane, Town of Fenton, to check the welfare of two occupants of a vehicle who were reported to be unconscious. When deputies arrived, they located a 2010 Honda sedan parked in the parking lot of the business. The vehicle had switched license plates affixed to it and was found to be unregistered, uninsured, and uninspected. Deputies located a male in the driver's seat and a female in the passenger. They were both asleep. Witnesses present at the scene stated they watched the vehicle enter the parking lot with a white male operating the vehicle. While speaking with the male, identified as Louis Mulieri, he displayed signs of being under the influence of an intoxicant. Mulieri had slurred and incoherent speech, bloodshot and droopy eyes, and difficulty walking. A certified and trained Drug Recognition Expert administered roadside field sobriety tests. Mulieri performed poorly during testing and was taken into custody under the suspicion of driving while impaired by drugs. During the investigation, Mulieri was found to possess two pills identified as Dextroamphetamine, a Schedule II controlled substance. Dextroamphetamine is used recreationally as an aphrodisiac and euphoriant. During the investigation, Mulieri was found to be unlicensed. The vehicle was towed from the scene and Mulieri was transported to the Sheriff's Office headquarters for additional testing and arrest processing. The female passenger arranged for friends to pick her up.

While at the Sheriff's Office headquarters Mulieri's condition worsened, and he was transported to Binghamton General hospital. While there Mulieri lost consciousness and hospital staff had to administer several doses of Naloxone to revive him. Mulieri was ultimately charged with the offenses listed below and issued appearance tickets to appear in Court at a later date.
