The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Matthew S. Bartosik, age 21 of Conklin, NY, was charged with Murder in the 2<sup>nd</sup> Degree, a Class A-I Felony, Attempted Murder in the 1<sup>st</sup> Degree, a Class A-II Felony, Attempted Murder in the 2<sup>nd</sup> Degree, a Class A-II Felony, Criminal Use of a Firearm in the 1<sup>st</sup> Degree, a Class B Felony, Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, a Class C Felony, Aggravated Criminal Possession of a Weapon, a Class C Felony and Criminal Contempt in the 1<sub>st</sub> Degree, a Class E Felony, following an investigation into a fatal shooting in the Town of Conklin.

Jennifer M. Briggs, age 33 of Whitney Point, NY, was charged with Tampering with Physical Evidence, a Class E Felony and Falsely Reporting an Incident in the 3<sup>rd</sup> Degree, a Class A Misdemeanor, following an investigation into a reported robbery in the Town of Triangle.

Angela E. Feitzinger, age 35 of Windsor, NY, was charged with Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, and three (3) counts of Endangering the Welfare of a Child, Class A Misdemeanors, following an investigation into suspicious behavior in the Town of Windsor.

Nakia M. Forbes, age 38 of Endicott, NY, was charged with Driving While Intoxicated (1<sup>st</sup> Offense) and Operating a Motor Vehicle with .08 of 1% of Alcohol in the System, both Misdemeanors, following a traffic stop in the City of Binghamton.

Anthony R. Mendez, age 32 of Endicott, NY, was charged with Criminal Contempt in the 1<sup>st</sup> Degree, a Class E Felony, following an investigation into an on-view offense in the City of Binghamton.

Samuel C. Michaels, age 27 of Cuddebackville, NY, was charged with Tampering with Physical Evidence, a Class E Felony, Providing a False Written Statement, a Class a Misdemeanor, and Falsely Reporting an incident in the 3<sup>rd</sup> Degree, a Class A Misdemeanor, following an investigation into a reported robbery in the Town of Triangle.

Daniel R. Mills, age 46 of Deposit, NY, was charged with Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, following a traffic stop in the City of Binghamton.

Jonathan M. Place, age 32 of Binghamton, NY, was charged with Criminal Trespass in the 3<sup>rd</sup> Degree, a Class B Misdemeanor, following a trespassing investigation in the City of Binghamton.

Rachel D. Ray, age 33 of the Town of Dickinson, NY was charged with False Personation, a Class B Misdemeanor, following an investigation into an on-view offense in the City of Binghamton.

Glenn E. Stevens, age 69 of Harpursville, NY, was charged with Harassment in the 2<sup>nd</sup> Degree (Physical Contact), a Violation, following an investigation into a dispute in the Town of Colesville.
