The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Jennifer M. Briggs, age 33 of Whitney Point, NY, was charged with Tampering with Physical Evidence, a Class E Felony and Falsely Reporting an Incident in the 3rd Degree, a Class A Misdemeanor, following an investigation into a reported robbery in the Town of Triangle.

Angela E. Feitzinger, age 35 of Windsor, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, and three (3) counts of Endangering the Welfare of a Child, Class A Misdemeanors, following an investigation into suspicious behavior in the Town of Windsor.

Nakia M. Forbes, age 38 of Endicott, NY, was charged with Driving While Intoxicated (1st Offense) and Operating a Motor Vehicle with .08 of 1% of Alcohol in the System, both Misdemeanors, following a traffic stop in the City of Binghamton.

Jonathan M. Place, age 32 of Binghamton, NY, was charged with Criminal Trespass in the 3rd Degree, a Class B Misdemeanor, following a trespassing investigation in the City of Binghamton.
