Zimmer, age 57 of Whitney Point, NY, was charged with Reckless Endangerment in the 1st Degree, a Class D Felony, Tampering with Physical Evidence, a Class E Felony, Unlawful Fleeing a Police Officer in a Motor Vehicle in the 3rd Degree, a Class A Misdemeanor, Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, Reckless Driving, a Misdemeanor, Aggravated Unlicensed Operation of a Motor Vehicle in the 3rd Degree, a Misdemeanor and over 30 traffic violations following a high-speed pursuit in the Town of Fenton.
