Joshua R. Moore, age 27 of Maine, NY, was charged with Criminal Contempt in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, and Harassment in the 2<sup>nd</sup> Degree, a Violation, following an investigation into an order of protection violation in the Town of Maine.
