The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Devin D. Collins, age 20 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, following a warrant execution in the Town of Dickinson.

Jennifer L. Franks, age 41 of Binghamton, NY was charged with Criminal Contempt in the 2^{nd} Degree, a Class A Misdemeanor, following an investigation into a call for service in the Town of Union.

Hector M. Medina, III, age 28 of Endicott, NY, was charged with Criminal Mischief in the 3rd Degree, a Class E Felony and Criminal Obstruction of Breathing/Blood Circulation, a Class A Misdemeanor, following a warrant execution in the Town of Union.

Steven M. Mullineaux, age 58 of Johnson City, NY, was charged with Aggravated Unlicensed Operation of a Motor Vehicle in the 1st Degree, a Class E Felony, following a traffic stop in the City of Binghamton.

Romario M. Robinson, age 27 of Port Crane, NY, was charged with two (2) separate counts of Aggravated Unlicensed Operation of a Motor Vehicle in the 1st Degree, a Class E Felonies, following traffic stops in the Town of Dickinson and the Town of Union.

Corey J. Vymislicky, age 36, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into a domestic incident in the Town of Fenton.

Kane L. Williams, age 28 of Vestal, NY, was charged with Endangering the Welfare of a Child, a Class A Misdemeanor, following an investigation into a domestic incident in the Town of Union.

Matthew A. Williams, age 32 of Conklin, NY, was charged with Resisting Arrest, Obstruction of Governmental Administration in the 2nd Degree and Criminal Possession of a Controlled Substance in the 7th Degree, Class A Misdemeanors, following a warrant execution in the Town of Conklin.
