## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE

### February 10, 2026 Weekly Arrests

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Johnathan Ayala, age 25, of Binghamton, NY, was charged with Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, a Class C Felony, Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree, a Class E Felony, and Unlawful Possession of an Ammunition Feeding Device, a Class B Misdemeanor, following an investigation into gunshots fired in the Town of Dickinson.

Devin J. Felton, age 36 of Binghamton, NY, was charged with Resisting Arrest, a Class A Misdemeanor, Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, and Driving While Intoxicated (1<sup>st</sup> Offense), a Misdemeanor, following a traffic stop in the Village of Johnson City.

Anthony J. Goodwin, Sr., age 37 of Scranton, PA, was charged with Resisting Arrest, Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree, and Criminal Mischief in the 4<sup>th</sup> Degree, Class A Misdemeanors, following a warrant execution in the Town of Kirkwood.

Isaiah N. Johnson, age 21, of Binghamton, NY, was charged with Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, a Class C Felony, Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree, a Class D Felony, and Criminal Possession of a Weapon in the 4<sup>th</sup> Degree, a Class A Misdemeanor following an investigation into gunshots fired in the Town of Dickinson.

Angela M. McCarthy, age 41, was charged with Promoting Prison Contraband in the 1<sup>st</sup> Degree, a Class D Felony, and Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, following an investigation during the intake process at the Broome County Correctional Facility.

Richard L. Stafford, III, age 33, was charged with Menacing in the 1<sup>st</sup> Degree, a Class E Felony, following an investigation into a dispute in the Town of Chenango.

Jahliek A. Walker-Coates, age 21, of Binghamton, NY, was charged with Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, a Class C Felony, Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree, a Class D Felony, Criminal Possession of a Weapon in the 4<sup>th</sup> Degree, a Class A Misdemeanor following an investigation into gunshots fired in the Town of Dickinson.

Samear N. Wallace, age 19, of Binghamton, NY, was charged with three (3) Counts of Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree, Class D Felonies, two (2) Counts of Criminal Possession of a Weapon 2<sup>nd</sup> in the Degree, Class C Felonies and two (2) Counts of Criminal Possession of a Weapon 4<sup>th</sup> in the Degree, Class A Misdemeanors, following an investigation into gunshots fired in the Town of Dickinson.
