Lindsey, age 24 of Binghamton, NY, was charged with Criminal Mischief in the 3rd Degree, a Class E Felony, Criminal Trespass in the 2nd Degree a Class A Misdemeanor, Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, and Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, following an investigation into a domestic incident in the Town of Kirkwood.

Alycia M. Rinwalske, age 36 of Binghamton, NY, was charged with three (3) counts of Identity Theft in the 2nd Degree, Class E Felonies, three (3) counts of Criminal Possession of Stolen Property in the 4th Degree, Class E Felonies, one (1) count of Grand Larceny in the 4th Degree, a Class E Felony, and three (3) counts of Petit Larceny, Class A Misdemeanors, following a larceny investigation in the City of Binghamton, Town of Vestal and Town of Union.

Anaya N. Wilkinson, age 21 of Chenango Forks, NY, was charged with Grand Larceny in the 4th Degree, a Class E Felony, following a larceny investigation in the Town of Fenton.
