Alycia M. Rinwalske, age 36 of Binghamton, NY, was charged with three (3) counts of Identity Theft in the 2<sup>nd</sup> Degree, Class E Felonies, three (3) counts of Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree, Class E Felonies, one (1) count of Grand Larceny in the 4<sup>th</sup> Degree, a Class E Felony, and three (3) counts of Petit Larceny, Class A Misdemeanors, following a larceny investigation in the City of Binghamton, Town of Vestal and Town of Union.
