## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE

*February 29, 2024 Weekly Arrest Blotter*

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

James F. Bell, Jr., age 47 of Binghamton, NY and Rick J. Knight, age 53 of Conklin, NY were both charged with two counts of Criminal Possession of a Controlled Substance the 7<sup>th</sup> Degree, Class A Misdemeanors following a traffic stop in the Town of Union.

Daniel B. Witney, age 34 of Binghamton, NY was charged with Harassment in the 2<sup>nd</sup> Degree (Physical Contact), a Violation, following a harassment complaint in the Town of Chenango.

William M. MacDowall, age 57 of Binghamton, NY was charged with Hindering Prosecution in the 3<sup>rd</sup> Degree and Obstructing Governmental Administration in the 2<sup>nd</sup> Degree, Class A Misdemeanors, after hindering police from entering his residence to arrest his son, Justin MacDowall, on an active felony bench warrant for Violation of Probation and an active arrest warrant for Strangulation in the 2<sup>nd</sup> Degree during a warrant execution in the Town of Binghamton.

Justin MacDowall, age 25 of Binghamton, NY was charged with Resisting Arrest and Obstructing Governmental Administration in the 2<sup>nd</sup> Degree, Class A Misdemeanors after refusing to allow police to execute two valid warrants for his arrest (Violation of Probation and Strangulation in the 2<sup>nd</sup> Degree) in the Town of Binghamton.

Harmony J. Alexander, age 24 of Rochester, NY was charged with Bail Jumping in the 2<sup>nd</sup> Degree, a Class E Felony, following an arrest on separate charges in Monroe County.
