Starke, age 38, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, Criminal Use of Drug Paraphernalia in the 2nd Degree and Obstruction of Governmental Administration in the 2nd Degree, Class A Misdemeanors, following a narcotics investigation in the City of Binghamton.

Rose M. Wahl, age 66 of Endicott, NY, was charged with Harassment in the 2nd Degree, a Violation, following an investigation into a domestic incident in the Town of Union.
