The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Brent J. Angeline, age 43 of Endicott, NY was charged with Criminal Contempt in the 1st Degree (Having previous conviction of Contempt in the 2nd Degree within years), a Class E Felony, following an investigation into a violation of a stay away order of protection in the Town of Union.

Geoffrey A. Brooks, age 30 of Windsor, NY, was charged with Unlawful Fleeing a Police Officer in the 3rd Degree, a Class A Misdemeanor, Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, and several traffic violations following a traffic stop and pursuit in the Town of Dickinson.

Alexis L. Cartagena, age 28 of Binghamton, NY and Jarvis L. Waayan, age 41 of Endicott NY, were each charged with Criminal Possession of a Controlled Substance in the 7th Degree, Class A Misdemeanors, following a traffic stop in the Town of Union.

Scott P. Haseltine, age 57 of Endicott, NY, was charged with Menacing in the 2nd Degree (Weapon), Endangering the Welfare of a Child, a Class A Misdemeanor, and Harassment in the 2nd Degree, a Violation following a warrant execution in the City of Binghamton.

Scott L. Knickerbocker Jr., age 39 of Windsor, NY was charged with Trespassing and Illegal Dumping, both Violations, following an investigation into a dumping complaint in the Town of Windsor.

Shaheen, age 39 of Binghamton, NY, was charged with Criminal Possession of a Weapon in the 3rd Degree (Defaced for Concealment), a Class D Felony, Criminal Possession of a Firearm, a Class E Felony, Two Counts of Endangering the Welfare of a Child, a Class A Misdemeanor, Six Counts of Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, Two separate charges of Criminal Use of Drug Paraphernalia in the 2nd Degree, a Class A Misdemeanor following an investigation into a suspicious incident in the Town of Chenango.
