The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Nicholas A. Bagg, age 22 of Windsor, NY, was charged with Criminal Obstruction of Breathing/Blood Circulation, a Class A Misdemeanor, following an investigation into a domestic incident in the Town of Windsor.

Douglas E. Symanski, age 41, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into an order of protection violation in the Town of Lisle.

Bridget M. Wilmarth, age 29 of Endicott, NY, was charged with Promoting Prison Contraband in the 1st Degree, a Class D Felony and Promoting Prison Contraband in the 2nd Degree, a Class A Misdemeanor, following a contraband investigation in the Broome County Correctional Facility.
