BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE May 6, 2025 Weekly Arrest Blotter

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Nicole L. Beebe, age 42 of Greene, NY, was charged with Criminal Possession in the 7th Degree and Resisting Arrest, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

Dilan G. Bernard, age 33, was charged with Possession of a Forged Instrument in the 2nd Degree, a Class D Felony and Grand Larceny in the 4th Degree, a Class E Felony, following a forgery investigation in the Village of Johnson City.

Jordan P. Charles, age 33 of Deposit, NY, was charged with Petit Larceny, a Class A Misdemeanor and Criminal Trespass, a Violation, following a larceny investigation in the Village of Deposit.

Anthony M. Kammerer, age 61 of Binghamton, NY, was charged with three (3) counts of Petit Larceny, Class A Misdemeanors, following three (3) separate larceny investigations in the Town of Union.

Olivia B. Kellogg, age 35 of Binghamton, NY, was charged with Assault in the 2nd Degree, a Class D Felony, Assault in the 3rd Degree, a Class A Misdemeanor, Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor and two (2) counts of Criminal Mischief in the 4th Degree, Class A Misdemeanors, following an investigation into property damage/vandalism in the Town of Chenango.

Melissa L. Phillips, age 53 of Windsor, NY, was charged with Criminal Use of Drug Paraphernalia in the 2nd Degree and Criminal Possession of a Controlled Substance in the 7th Degree, Class A Misdemeanors, following a traffic stop in the Town of Kirkwood.

Nicholas N. Neer, age 37 of Port Crane, NY, was charged with Petit Larceny, a Class A Misdemeanor, following a larceny investigation in the Town of Chenango.
