The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Nicolas G. Arias, age 23 of Binghamton, NY, was charged with two (2) counts of Menacing a Police Officer, a Class D Felony, Obstructing Governmental Administration, a Class A Misdemeanor, and Criminal Possession of a Weapon in the 4th Degree, a Class A Misdemeanor, following a menacing investigation in the City of Binghamton.

Jason N. Diamond, age 44 of Port Crane, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor and Obstructing Governmental Administration in the 2nd Degree, a Class A Misdemeanor, following a traffic stop in the City of Binghamton.

Rondell V. Dowdell, age 37 of Endicott, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, along with multiple traffic violations, following a traffic stop in the Village of Johnson City.

Alexander J. Fahs, age 34 of Endicott, NY, was charged with Criminal Contempt in the 1st Degree, a Class E Felony and Criminal Mischief in the 3rd Degree, a Class E Felony, following an investigation into an order of protection violation in the Town of Union.

Angel D. Gonzalez, age 25 of Binghamton, NY, was charged with Promoting Prison Contraband in the 1st Degree, a Class D Felony and Tampering with Physical Evidence, a Class E Felony, following a contraband investigation in the Broome County Correctional Facility.

Gavin T. Swartz, age 28 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor and Possession of Burglar Tools, a Class A Misdemeanor, following an investigation into suspicious activity in the Town of Union.

Sweeny, age 43 of Friendsville, PA, was charged with Driving While Intoxicated (Previous Conviction Within 10 Years), a Class E Felony, Criminal Possession of a Weapon in the 2nd Degree, a Class C Felony, and Criminal Possession a Weapon in the 3rd Degree (Previous Conviction), a Class D Felony, along with multiple traffic violations, following a traffic stop in the Village of Endicott.
