Missing Person: Juvenile Female Last Seen in the First Ward Area of Binghamton

(TOWN OF FENTON, NY) The Broome County Sheriff's Office is continuing an investigation into a missing juvenile in the Town of Fenton.

Ciara L. Culpepper, age 15 of the Town of Fenton was last reported missing from the Children's Home of Wyoming Conference on April 23, 2026.

This is the sixth incident in which Culpepper has been reported missing since October 2025. Following previous missing person reports, Culpepper was located by law enforcement along the Main St. corridor of the City of Binghamton and the Village of Johnson City.

As Broome County Sheriff's Office and local law enforcement continued their investigation into the most recent missing persons report, Culpepper was reportedly seen on Main St., Clinton St., and Jarvis St., in the City of Binghamton over the past few weeks.

Culpepper is described as a black female, standing 5'4" and weighing approximately 140 lbs. with brown hair and glasses.

The Sheriff's Office is attempting to locate Ciara Culpepper, ensure her safety and reconnect her with the Children's Home of Wyoming Conference.

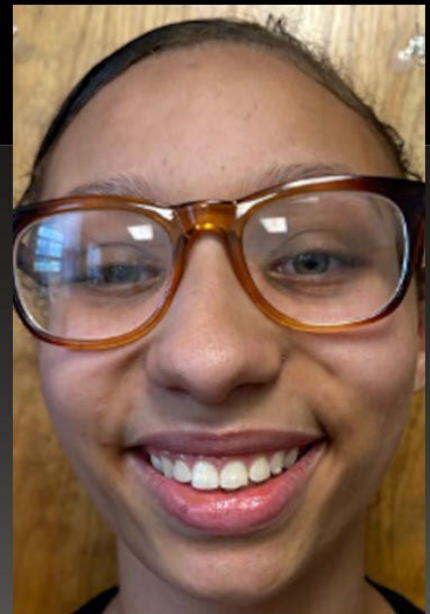
