June 18, 2025 Weekly Arrests

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Joseph R. Buchanan, Jr., age 60, was charged with Petit Larceny, a Class A Misdemeanor, following a larceny investigation in the City of Binghamton.

Lester D. Dillon, age 35 of Binghamton, NY, was charged with Driving While Intoxicated (1st Offense), a Misdemeanor, Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, Unlawful Possession of a Certain Ammo Feed Device (1st Offense), a Class B Misdemeanor, and several traffic violations following a traffic stop in the Town of Binghamton. Following a separate investigation into a domestic incident in the Town of Binghamton, Dillon was charged with Reckless Endangerment in the 1st Degree, a Class D Felony, Endangering the Welfare of a Child, a Class A Misdemeanor, and Aggravated Harassment in the 2nd Degree, a Class A Misdemeanor.

Marshall G. Gjiza, age 30 of Johnson City, NY, was charged with Resisting Arrest and Obstruction of Governmental Administration in the 2nd Degree, Class A Misdemeanors, following a warrant execution related to separate charges in the Village of Johnson City.

Beth A. Harasta, age 38 was charged with three (3) counts of Petit Larceny, following a larceny investigation in the Town of Union.

David P. Kellerman, age 66 of Port Crane, NY, was charged with Making a Terroristic Threat, a Class D Felony, following an investigation into threatening messages sent in the Town of Fenton.

Owens, age 30 of Binghamton, NY, was charged with Criminal Mischief in the 3rd Degree, a Class E Felony, Resisting Arrest, a Class A Misdemeanor, Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor, and Criminal Trespass in the 2nd Degree, a Class A Misdemeanor, following an investigation into a dispute in the Town of Dickinson.

Jose M. Vazquez, age 39 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor and Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor, following a traffic stop in the Village of Johnson City.

Kristine E. Webb, age 53 of Binghamton, NY, was charged with Driving While Intoxicated (1st Offense), a Misdemeanor, Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor, and several traffic violations following an investigation into suspicious activity in the Town of Fenton.

Thomas W. Williams, age 22 of Endicott, NY, was charged with Harassment in the 2nd Degree, a Violation, following an investigation into a dispute in the Town of Union.

Jesse J. Wolcott, age 38 of Binghamton, NY, was charged with Criminal Trespass in the 3rd Degree, a Class B Misdemeanor, following a criminal trespassing investigation in the Town of Chenango.
