Wolcott, age 38, was charged with Burglary in the 2<sup>nd</sup> Degree, a Class C Felony and Criminal Mischief in the 3<sup>rd</sup> Degree, a Class E Felony, following a burglary investigation in the Town of Chenango. Wolcott was also charged with three (3) counts of Criminal Trespass in the 3<sup>rd</sup> Degree, Class B Misdemeanors and Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, following separate trespassing investigations in the Town of Chenango.

Christiana E. Yacalis, age 28 of Binghamton, NY, was charged with two (2) counts of Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

Elijah Yard, age 27 of Binghamton, NY, was charged with Unlawful Fleeing a Police Officer in a Motor Vehicle in the 3<sup>rd</sup> Degree, Reckless Endangerment in the 2<sup>nd</sup> Degree, and Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree, Class A Misdemeanors, along with several traffic violations following a pursuit and traffic stop in the Town of Dickinson.
