Dustin A. Parmelee, age 38 of Kirkwood, NY, was charged with Criminal Contempt in the 2^{nd} Degree, a Class A Misdemeanor, following an investigation into a violation of an order of protection in the Town of Binghamton.

Samuel V. Reynolds, age 29 of Endicott, NY, was charged with Harassment in the 2nd Degree (Physical Contact), a Violation, following an investigation into a domestic incident in the Town of Union.

Kevin M. Russell, age 34, was charged with Grand Larceny in the 4th Degree (Value Greater Than \$1,000), a Class E Felony, Conspiracy in the 5th Degree, as well as Resisting Arrest and Obstruction of Governmental Administration in the 2nd Degree, Class A Misdemeanors, following a larceny investigation the Town of Chenango.

Matthew T. Ward, age 38 of Castle Creek, NY, was charged with Criminal Mischief in the 2nd Degree, a Class D Felony and Criminal Mischief in the 3rd Degree, a Class E Felony, following an investigation into property destruction in the Town of Chenango.
