The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Chad S. Congdon, age 34 of Port Crane, NY, was charged with Driving While Intoxicated (1st Offense), Aggravated DWI (BAC .18 or More), and Reckless Driving Misdemeanors, along with multiple traffic violations, following a DWI investigation in the Town of Colesville.

Niculae, I. Goicea, age 76 of Binghamton, NY, was charged with Petit Larceny, following a larceny investigation in the Town of Union.

Gonzalez, age 35 of Port Crane, NY, was charged with Strangulation in the 2nd Degree, a Class D Felony, two (2) counts of Assault in the 3rd Degree, Class A Misdemeanors, and Menacing in the 3rd Degree, a Class B Misdemeanor, following an investigation into a domestic incident in the Town of Fenton.
