The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Crispell, age 36 of Binghamton, NY, was charged with Aggravated Family Offense, a Class E Felony, Obstruction of Governmental Administration in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, Criminal Contempt in the 2<sup>nd</sup> Degree, a Class A Misdemeanor and False Personation, a Class B Misdemeanor, following a traffic stop in the City of Binghamton.

Johnathan D. Dix, age 53 of Thompson, PA, was charged with two counts of Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

Seth V. Jennings, age 30 of Binghamton, NY, was charged with Petit Larceny, a Class A Misdemeanor, following a larceny investigation in the Town of Dickinson.

Little, age 27 of Apalachin, NY, was charged with Strangulation in the 2<sup>nd</sup> Degree, a Class D Felony, Assault in the 3<sup>rd</sup> Degree, a Class A Misdemeanor and Reckless Endangerment in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, following an investigation into a domestic incident in the Town of Union.

Camille L. Morrissey, age 27 of Binghamton, NY, was charged with Obstructing Governmental Administration in the 2<sup>nd</sup> Degree and Resisting Arrest, Class A Misdemeanors, following a warrant execution in the City of Binghamton.

Bobbie Jo Newman, age 54 of Binghamton, NY was charged with Grand Larceny in the 4<sup>th</sup> Degree a Class E Felony, two counts of Petit Larceny and two counts of Identity Theft in the 3<sup>rd</sup> Degree, Class A Misdemeanors, following a larceny investigation in the Towns of Union, Vestal and Windsor. As a result of the same investigation, Darnell C. Mitchell, age 60, was charged with two counts of Petit Larceny and two counts of Identity Theft in the 3<sup>rd</sup> Degree, Class A Misdemeanors.

Joseph C. Page, age 23 of the Town of Kirkwood, was charged with Criminal Contempt in the 2<sup>nd</sup> Degree, following an investigation into a violation of an order of protection in the Town of Kirkwood.

Pete A. Pena, age 45 of Great Bend, PA, was charged with Robbery in the 2<sup>nd</sup> Degree (Causing Physical Injury), a Class C Felony, following a robbery investigation in the Town of Conklin.

Brianna M. Ramstine, age 20 of Chenango Forks, NY, was charged with Aggravated Driving While Intoxicated (BAC of .18% or higher) and Driving While Intoxicated (1<sup>st</sup> Offense), Misdemeanors, and issued multiple traffic tickets following an investigation into a disabled vehicle in the Town of Chenango.

Damien R. Spencer, age 43 of Endicott, NY, was charge with Petit Larceny, a Class A Misdemeanor, following a larceny investigation in the Town of Chenango.

Harley D. Smith, age 20 of Endicott, NY was charged with Assault in the 3<sup>rd</sup> Degree, a Class A Misdemeanor, following an investigation into a domestic dispute in the City of Binghamton.

Demetrius D. Thompson, age 43, was charged with two counts of Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree and two counts of Identity Theft in the 2<sup>nd</sup> Degree, Class E Felonies, following a larceny investigation in the Town of Union.

James A. Woodard, age 38 of Windsor, NY, was charged with Official Misconduct, a Class A Misdemeanor and Harassment in the 2<sup>nd</sup> Degree, a Violation, following an investigation into an on-view offense in the Town of Dickinson.
