Keller, Sr., age 54 of Windsor, NY, was charged with three counts of Criminal Possession of a Weapon in the 4th Degree (While having a previous felony conviction), a Class A Misdemeanor, Menacing in the 2nd Degree (Weapon), a Class A Misdemeanor, Criminal Mischief in the 4th Degree (Preventing Victim from Requesting Emergency Assistance), a Class A Misdemeanor and Harassment in the 2nd Degree, a Violation, following a domestic incident investigation in the Town of Windsor.
