The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Holly J. Cox, age 20 of Binghamton, NY, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into an order of protection violation in the Town of Colesville.

Renee R. Dufford, age 49 of Chenango Forks, NY, was charged with Petit Larceny, a Class A Misdemeanor, following a larceny investigation in the Town of Kirkwood.

Jordan T. Hawk, age 29 of Windsor, NY, was charged with Criminal Possession of Stolen Property in the 4th Degree, a Class E Felony, following an investigation into a stolen motorcycle in the Town of Windsor.

Dominic T. Kasmarcik, age 26 of Binghamton, NY, was charged with Grand Larceny in the 4th Degree, a Class E Felony, following a larceny investigation in the Town of Kirkwood.

Bianca Petruzzella, age 48 of Port Crane, NY, was charged with Driving While Intoxicated (1st Offense), a Misdemeanor, along with multiple traffic violations, following an investigation into a motor vehicle accident in the Town of Dickinson.

Rodney A. Randall, age 48 of Conklin, NY, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into an order of protection violation in the Town of Conklin.

Richard C. Rockwell, age 30 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, following a traffic stop in the City of Binghamton.

William M. Vandermark, age 64 of Harpursville, NY, was charged with four (4) counts of Child Endangerment, a Class A Misdemeanor, following an investigation into a dispute in the Town of Colesville. Vandermark was also charged with Criminal Trespass in the 3rd Degree, a Class B Misdemeanor, following a seperate investigation into trespassing in the Town of Colesville.
