Briggs, age 40 of East Syracuse, NY, was charged with Driving While Intoxicated (1st Offense) Operating a Motor Vehicle w/ BAC >.08 (1st Offense), Reckless Driving, and Aggravated Unlicensed Operation of a Motor Vehicle in the 3rd Degree, Misdemeanors, along with multiple traffic violations, following a traffic stop in the Town of Union.

Cleveland, age 39 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance w/Intent to Sell in the 5th Degree, a Class D Felony, Obstructing Governmental Administration in the 2nd Degree, a Class A Misdemeanor and False Personation, a Class B Misdemeanor, following a traffic stop in the Town of Union.

Darren M. Clouser, age 52 of Endicott, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor and False Personation, a Class B Misdemeanor, following an investigation into a domestic incident in the Town of Union. Clouser was also charged Criminal Mischief in the 4th Degree, a Class A Misdemeanor, following a separate investigation into property damage in the Town of Union.

Kareem A. Davis, age 46 of Binghamton, NY, was charged with DWI (previous conviction within 10 yrs) and Aggravated Unlicensed Operation of a Motor Vehicle in the 1st Degree, Class E Felonies, along with multiple traffic violations, following a traffic stop in the Village of Endicott.

Ryan S. Hudak, age 33 of Vestal, NY, was charged with two (2) counts of Sex Abuse in the 1st Degree, Class D Felonies, following a sex abuse investigation in the Town of Chenango.

Ethan M. Kasmarcik, age 19 of Endicott, NY, was charged with two (2) counts of Rape in the 2nd Degree, Class D Felonies, following a rape investigation in the Town of Union.

Edward J. Oczkowski, Jr., age 36 of Binghamton, NY, was charged with Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, following a traffic stop in the City of Binghamton.

Daisy A. Saracino, age 45 of Johnson City, NY, was charged with Driving While Intoxicated (1st Offense) and Operating a Motor Vehicle w/BAC>.08 (1st Offense), Misdemeanors, along with multiple traffic violations, following a traffic stop in the Town of Dickinson.
