The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Jake E. Felter, age 19 of Castle Creek, NY, was charged with Driving While Intoxicated (1st Offense) a Misdemeanor, Operating a Motor Vehicle w/ BAC>.08 (1st Offense), a Misdemeanor, Reckless Endangerment in the 2nd Degree, a Class A Misdemeanor, Reckless Driving, a Misdemeanor and multiple traffic violations, following an investigation into a road rage incident in the Town of Chenango.

Christopher A. Lafever, age 63 of the Town of Chenango, NY, was charged with Criminal Obstruction of Breathing/Blood Circulation, a Class A Misdemeanor, following an investigation into a domestic incident in the Town of Chenango.

Giovanni O. Olan, age 29 of Binghamton, NY, was charged with two (2) counts of Criminal Possession of a Controlled Substance in the 7th Degree, Class A Misdemeanors, following a narcotics investigation in the City of Binghamton.

Rebecca G. Petrilli, age 52 of Endicott, NY, was charged with Harassment in the 2nd Degree, a Violation, following an investigation into a domestic incident in the Town of Union.

Robert W. Rogers, Jr., age 62 of Vestal, NY, was charged with DWAI (Prior Conviction), a Class E Felony, Tampering with Physical Evidence, a Class E Felony, two (2) counts of Criminal Possession of a Controlled Substance in the 7th Degree, Class A Misdemeanors, Aggravated Unlicensed Operation of a Motor Vehicle in the 3rd Degree, a Misdemeanor, and Reckless Driving, a Misdemeanor, along with multiple traffic violations, following a traffic stop in the Town of Dickinson.

Lucas J. Rought, age 41 of Endicott, NY, was charged with Obstruction of Governmental Administration in the 2nd Degree, a Class A Misdemeanor and Criminal Trespass in the 3rd Degree, a Class B Misdemeanor, following a joint operation with the Office of Cannabis Management.

Waqar Waheed, age 50, was charged with two (2) counts of Child Endangerment, three (3) counts of Criminal Contempt in the 2nd Degree and Criminal Mischief in the 4th Degree, Class A Misdemeanors, following an investigation into a domestic incident in the Town of Dickinson.

Shadoe T.M. Warren, age 35 of Binghamton, NY, was charged with two (2) counts of Criminal Possession of a Controlled Substance in the 7th Degree and Criminal Use of Drug Paraphernalia in the 2nd Degree, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

Robert C. Wilson, Jr., age 21 of Binghamton, NY, was charged with Criminal Contempt in the 2nd Degree, a Class A Misdemeanor, following an investigation into an order of protection violation at the Broome County Correctional Facility.
