September 16, 2025 Weekly Arrests

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Nicholas Ambrose, age 25 of Binghamton, NY was charged with four (4) counts of Criminal Contempt in the 1st Degree, Class E Felonies, after an investigation into multiple order of protection violations at the Broome County Correctional Facility.

Orlando L. Ayala, age 47, was charged with Identity Theft in the 2nd Degree and Criminal Possession of Stolen Property in the 4th Degree, Class E Felonies, following a larceny investigation in the Town of Union.

Devin Ellis, age 29, was charged with Promoting Prison Contraband in the 1st Degree, a Class D Felony, following a contraband investigation at the Broome County Correctional Facility.

Sean L. Hawkins, age 40 of the Town of Dickinson, NY, was charged with Criminal Obstruction of Breathing or Blood Circulation and Child Endangerment, Class A Misdemeanors, following an investigation into an offense involving a child in the Town of Binghamton.

Kyle Nowalk, age 27 of Binghamton, NY, was charged with Assault in the 2nd Degree, a Class D Felony, following an investigation into a physical altercation at the Broome County Correctional Facility.

Jasmine M. Petrosky, age 26 of Binghamton, NY, was charged with Identity Theft in the 2nd Degree, a Class E Felony, following a larceny investigation in the Town of Union.

Christopher C. Ramey, age 44 of Port Crane, NY, was charged with Reckless Endangerment in the 2nd Degree, Unlawful Fleeing a Police Officer in a Motor Vehicle in the 3rd Degree and Obstruction of Governmental Administration in the 2nd Degree, Class A Misdemeanors, following a vehicle pursuit in the City of Binghamton.

Michael A. Roma, age 53 of Johnson City, NY, was charged with Criminal Contempt in the 1st Degree, a Class E Felony, Strangulation in the 2nd Degree, a Class D Felony, and Harassment in the 2nd Degree, a Violation, following an investigation into a domestic incident in the Town of Union.

Jesse M. Shaw, age 35 of Hancock, NY, was charged with Operating a Motor Vehicle Impaired by Drugs (1st Offense), a Misdemeanor, four (4) counts of Criminal Possession of a Controlled Substance in the 7th Degree, and Criminal Use of Drug Paraphernalia in the 2nd Degree, Class A Misdemeanors, following a traffic stop in the City of Binghamton.

Daniel B. Witney, age 36 of the Town of Chenango, NY, was charged with Rape in the 3rd Degree, a Class E Felony, Patronizing a Person for Prostitution in the 3rd Degree, a Class A Misdemeanor, two (2) counts of Child Endangerment, Class A Misdemeanors, two (2) counts of Unlawfully Dealing with a Child in the 1st Degree, Class A Misdemeanors, and Criminal Possession of a Controlled Substance in the 7th Degree, a Class A Misdemeanor, following a statutory rape investigation in the Town of Chenango.
