## BROOME COUNTY SHERIFF'S OFFICE PRESS RELEASE

The following update includes recent arrests and charges made by the Broome County Sheriff's Office.

Michael P. Benza, age 24 of Binghamton, NY, was charged with Driving While Intoxicated (1<sup>st</sup> Offense), a Misdemeanor, and Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree, a Class A Misdemeanor, following a traffic stop in the City of Binghamton.

Damien M. Brown, age 22 of Binghamton, NY, was charged with Driving While Intoxicated (1<sup>st</sup> Offense) and Operating a Motor Vehicle w/ BAC>0.08, Misdemeanors, along with multiple traffic violations, following an investigation into a motor vehicle accident in the Town of Dickinson.

Rylan A. Cremard, age 18 of Windsor, NY, was charged with Reckless Endangerment in the 2<sup>nd</sup> Degree, a Class A Misdemeanor, along with multiple traffic violations, following a pursuit and traffic stop in the Town of Windsor.
