

Sheriff David E. Harder

2015 was another year of challenges for the Broome County Sheriff's Office.

- We had a turnover of 3 Undersheriff's in 2015. Alex Minor, who retired from the Binghamton Police Department after 40 years, served 5 years as Broome County Undersheriff. Fred Akshar rose through the ranks of the Sheriff's Law Enforcement division to Captain and then to Undersheriff for 3 months before deciding to run a successful campaign to the New York Senate for the 52nd District. I then brought on board retired Captain Eric Janis, who served 34 years with the New York State Police.
- We held one of the largest law enforcement academies, with 44 recruits from 10 different agencies, graduating upon the completion of 26 weeks of training. We also graduated 19 correction officers from 4 different agencies after 9 weeks of training.
- A large part of being a law enforcement officer is being in shape for the rigorous challenges ahead. Working with the administration of SUNY Broome, who made land available, we constructed an obstacle course for use by the academies. Several local venders and contractors made their services and material available at no cost. Not only do the academy recruits utilize this course, but it is also available to Criminal Justice students of SUNY Broome. (Refer to page 19 for further details)
- With increasing concern for people with Alzheimer's disease, Dementia, Autism and other such conditions that can cause them to wander, The Broome County Sheriff's Office has implemented "Project Lifesaver" to bring peace of mind to families, friends and communities. Through the process of a simple application, family members and caregivers can obtain a transmitter that is worn by the afflicted person whereby, in the event that they wander, they can be located quickly through the use of a receiver by deputies.
- Heroin has become an ever increasing problem. With the continued use of Naloxone- NARCAN, our deputies have been able to save many lives. To go a step further, we have started the "Sheriff's Assisted Recovery Initiative". Working with other local agencies, our mission is to facilitate assistance for addicts who come to us for help for a long term solution to their addiction.

The 2015 Annual Report will show that there has been an increase in the workload for the Sheriff's Office. Thanks to the hard work and dedication of the employees of the Broome County Sheriff's Office, who proved to be up to the task at hand.


Broome County Sheriff's Office Highway Patrol Division

2015



The Broome County Sheriff's Office Patrol Division is comprised of highly trained members who are prepared to respond to any incident that happens in any of the sixteen towns, seven villages or the City of Binghamton, which make up the County of Broome. Utilizing the 2014 population statistics, the Broome County Sheriff's Office Patrol Division is the primary Law Enforcement agency for 48 % of the residents in Broome County. The Patrol Division serves the residents of Broome County as they attend school, go to work and shop outside the city and village limits within the county. The Patrol Division also provides law enforcement services to the other six municipal police agencies within the county and answers call for service in their respective jurisdiction when the need arises. The Patrol Division enforces the laws of the State of New York and does so while proactively patrolling 1,008 miles of State Highways, 350 miles of county roadways and 927 miles of town roads on a twenty four hour a day, seven day a week basis. The Patrol Division is also equipped to handle specialized calls for service by deploying the Marine Unit, the Motor Unit, the K-9 unit and the SWAT Special Weapons and Tactics Team when the need arises.


During 2015, the Patrol Division handled 20,006 calls for service which was an increase of 706 calls from the 2014 total of 19,300. An additional 9,023 quick call complaints, which are generated by the deputies while they were working in their respective patrol zones, were recorded. A deputy will generate a "quick call" when they exit their patrol vehicle for a self-initiated investigation or when making a vehicle stop. A quick call may or may not generate an actual incident or a call for service. The following pages set forth a breakdown of these calls for service and the arrests made by the deputies


2014-2015 Comparison



Calls for Service & Quick Calls Day of the week




Calls for Service- By Shift

The following graph represents the total number of calls for service by month that were handled by members of the Highway Patrol Division. As is generally the case, the late spring and summer months are busier than the rest of the year.



Prioritizing Calls for Service

Calls for police service vary in the type of response that is dictated. Some calls are of an extreme emergency nature while others can be handled by the officer "sometime during their tour of duty." Still others require prompt attention but do not meet the criteria for an emergency response.

- 1. EMERGENCY CALLS generally mean the type of call that requires immediate response due to personal injury, substantial public inconvenience or the fact that another person has been placed in jeopardy of serious physical injury and which is likely to occur if police assistance is delayed in any manner.
- 2. ROUTINE CALLS generally mean those calls which have little or no chance for personal injury or harm to any person or little potential for causing substantial public inconvenience.

Emergency calls will be classified as "PRIORITY ONE" calls.

Examples of "PRIORITY ONE" calls might include:

- 1. A personal injury auto accident.
- 2. Any call in which there is a risk of death or serious physical injury.
- 3. A heated domestic violence case where weapons are involved.


Routine calls will be classified as "PRIORITY TWO" calls.

Examples of "PRIORITY TWO" calls might include:

- 1. Motor vehicle accidents without injury.
- 2. Non-violent disputes.
- 3. Response to minor criminal complaints.

Examples of "PRIORITY THREE" calls might include:

- 1. Calls for which an officer has a prior commitment such as an escort.
- 2. Calls in which an officer may check on anytime during his tour of duty.




Jurisdictional Breakdown






Patrol Division Vehicle and Traffic Enforcement

Academy Obstacle Course

In 2015, the Broome County Sheriff's Office completed construction of an obstacle course that will be used by not only the Law Enforcement Academy, but other entities as well. The project began in 2014 as a joint venture between the Broome County Sheriff's Office and SUNY Broome College. The obstacle course was designed to mimic the conditions a law enforcement officer may encounter during a foot pursuit; such as running, climbing, balance, squatting, crawling, jumping. Persons using the course will be challenged physically as a variety of skills are required; upper body, core and lower body strength are instrumental. The course will be incorporated into the Criminal Justice, Homeland Security, Fire Science and Physical Fitness programs at SUNY Broome College to enhance the current programs and create new ones. The course will also be used by military recruits, other law enforcement and fire agencies, law enforcement academy recruits and members of the Sheriff's Office.

The area where the course is built, north side of the Sheriff's Office, was an overgrown field that had to be mowed, leveled and drainage ditches re-structured. Seventeen (17) obstacles were built:

The project included donations from the public, Broome County Department resources and was built primarily by members of the Sheriff's Office. Multiple Broome County agencies, private businesses and members of the public assisted with construction of the course. Broome County Department of Parks & Recreation was a large contributor to the project with moving material, leveling the land, constructing water traps, loaning of equipment and manpower.

CANINE UNIT

The Canine unit is comprised of three teams. The dogs, two Dutch Shepherds and one German Shepherd, are each handled by a trained and certified Deputy Sheriff canine handler.

All three canines are trained in police patrol which includes certifications in area searches, building searches, tracking and suspect apprehension. In addition, each canine is further trained to specialize in either narcotics detection or explosive scent detection. The Sheriff's office currently has two narcotic detection canines and one explosive scent detection canine. The canine teams train eight (8) hours every other week.

The Sheriff Office canine teams are as follows:



Deputy Richard Merrell and Canine Ruger

Deputy Merrell has been employed with the Sheriff's Office for 9 years and a canine handler for 6 years. Canine Ruger is a 8 year old male Dutch Shepherd who is trained in narcotics detection. Deputy Merrell and Canine Ruger are part of the Broome-Endicott SWAT team and participate in additional training with the SWAT team several times per year.



Deputy Leon Brown and Canine Aevar

Deputy Brown has been with the Sheriff's Office for 9 years and a canine handler for 6 years. Canine Aevar is a 8 year old male Dutch Shepherd who is specially trained in explosive scent detection. Every year this team is deployed to Cornell University for two days in May for explosive detection/searches prior to commencement ceremonies.



Deputy Willard Andres and Canine Mac

Deputy Andres has been employed with the Sheriff's Office for 8 years and has been a canine handler for 3 ½ years. Canine Mac is a 5 ½ year old male German Shepherd who is trained in narcotics detection. Deputy Andres and Canine Mac participate in all requests for canine demonstrations in the community due to Canine Mac's friendly disposition. In 2015, as a team, they were involved in fourteen (14) demonstrations and about twenty-four (24) other community events. Canine Mac's strongest skill sets are tracking, narcotics detection and his approachable, mild temperament which lends well to community interaction.

<u>Honor Guard</u>



The Broome County Sheriff's Office Honor Guard detail is led by one Sergeant and several hand-picked deputies. The Honor Guard's primary duties include funeral honors for fallen and retired officers and to serve as Guardians of the Colors by displaying and escorting the National Flag during ceremonial events.

Events attended by the Sheriff's Office Honor Guard include National Police Week ceremonies, 09/11 remembrances and the annual Crime Victim's tribute. The Honor Guard also participates in several parades each year, most notably the annual St. Patrick's Day parade in Binghamton. The Honor Guard performed its most essential, yet unwelcomed duty, during the past year providing funeral honors for fallen police officers.

The uniform worn by the Honor Guard is the "class A" formal dress blouse with a gold shoulder cord and Sam Browne shoulder rig with attached duty belt, trousers, shined shoes and the Stetson hat.

Broome County Sheriff Motorcycle Unit Summary, 2015

The Broome County Sheriff's Motorcycle Unit began the 2015 riding season with a total of four full-time riders; Deputies Rob Fish, Sam Davis, Mike Kelly and Matt Obrien. During the course of the season, Deputy Davis was promoted to Sergeant and appointed as the Director of Training for the Academy which will remove him from full-time status. The Motor Unit can also utilize Lt. Ben Harting, Sgt. Scot McDonald, Sgt. Shaun Carnevale, Detective James Broderick and Detective Edward Sakowsky on a part-time basis as Unit back-up or coverage for events and details.



The Motor Unit is equipped with two Harley Davidson Police Motorcycles. One is a 2000 model FLHPI 88 Police Road King, designated as MC1. The second is a 2007 FLHPI 95 Police Road King designated as MC2. Both MC1 and MC2 were given a complete tune-up this spring and are in serviceable condition at this time. Additionally, we can transport one or both units in our 9x12 enclosed transport trailer. MC2 is equipped with a hard-mounted STALKER DUAL radar unit that can be utilized for both stationary and moving radar with both a front and rear antennae.

The Broome County Sheriff's Motorcycle Unit is looking forward to a safe and productive 2016 season. Our starting roster for the Motor Unit is slated at three full-time riders, with another six part-time riders available for special details. We anticipate the opportunity to expand our patrols and maintain our exposure to the public for the upcoming season.

DETECTIVE DIVISION

The Broome County Sheriff's Detective Division is comprised of two Detective Sergeants who supervise two divisions. The General Investigations Division Sergeant supervises four general investigations detectives, one juvenile detective, two deputy sheriffs assigned to the Warrant Division, and one property room clerk. The Special Investigations Sergeant supervises five SIU Detectives who are also assigned to the Broome County Special Investigations Task Force. Members assigned to the division maintain the sex offender registry, DNA gathering registry and evidence control. Members are assigned to the GIVE Initiative, Child Advocacy Case Review Committee, Gang Task Force Meetings, Counter Terrorism Zone Meetings, Bank Security Meetings and Retail Security Meetings. Members also provide presentations to various government and private groups.






CASE AND ARREST COMPARISON 2012-2015

SEX OFFENDER MONITORING




OffenderWatch® is updated instantaneously throughout the day as offender addresses and other offender information is updated in our office. You may enter any address in the County and see real-time information on the publishable offenders within the specified radius of the address you enter.

Offenders move frequently, so instead of having to check the maps on a weekly basis, the best way to stay informed is to take advantage of our free email alert system. You may confidentially register as many addresses in the County as you wish, and we will continuously monitor the addresses and send you an email alert if a new offender registers an address within the specified radius of any address you register. There is no cost for this service and no limit to the number of addresses you can register - your email address and physical addresses are all confidential. WARRANT UNIT

The Warrant Control Unit of the Broome County Sheriff's Office is comprised of two, (2) Deputy Sheriffs under the direction of the Detectives Sergeant assigned to General Investigations. The unit is responsible for the management of warrants issued to the Broome County Sheriff's Office by Broome County Supreme Court, Broome County Family Court and local Justice Courts throughout Broome County. The deputies assigned to the unit ensure entry of each warrant received into the Broome County Public Safety

System and eJusticeNY (The New York State Integrated Justice Portal). This helps to readily identify wanted persons who may be encountered by police officers locally or nationwide.

The Broome County Sheriff's Office continues to work with New York/New Jersey Regional Fugitive Task Force. Five Sheriff's Office members are sworn United States Deputy Marshals. They work along with members of the Marshal Service, Binghamton Police Department and New York State Police. The Regional Fugitive Task Force increases the resources available to better track fugitives not only in New York State but across the country.

The Warrant Control Unit distributes the warrants issued by Local Criminal Courts to Highway Patrol Deputies for execution and monitors the action taken. The Unit is responsible for the execution of all Broome County Court and Broome County Family Court warrants. In addition to New York State, the Unit is responsible for the extradition of wanted subjects that are located outside New York State.



JOSEPH ROSE

On February 26, 2015, detectives arrested Joseph A. Rose, 30 year old male of Endicott, New York. Rose is accused of stealing a motor vehicle containing approximately \$10,000.00 worth of electronic equipment. Detectives executed a search warrant at Rose's residence in the Village of Endicott and recovered all of the stolen equipment. Rose was charged with Grand Larceny in the 4th degree and Criminal Possession of Stolen Property in the 3rd degree, both felonies.



On June 6, 2015, the Sheriff's Office was notified that David Sweat and Richard Matt had escaped from Clinton Correctional Facility in Dannemora New York. Sweat was serving a life sentence for the killing of Broome County Deputy Sheriff Kevin Tarsia in July 2002. The detective division assisted the New York State Police with following up on several leads and conducting several interviews with Sweat's known associates. In addition, one detective and one warrant deputy traveled to Clinton and Franklin Counties to assist with the manhunt prior to Sweat's recapture



MATTHEW BACKUS

On July 15, 2015, detectives arrested Matthew A. Backus, 24 year old male of the Town of Maine for a violation of the New York State Sex Offender Registry. Backus is a level 3 sex offender having been convicted of Rape in the 2nd degree in 2010. Backus was accused of violating the requirements of the sex offender registry by failing to register his username and screen name on FACEBOOK, a popular social media website. Backus was charged with Failure to Register as required under the New York State Sex Offender Registry Act, a class E Felony.



EMILY BALENO

BRIDGETTE BENSLEY MARIE NEWKIRK

In August 2015, detectives arrested Emily Baleno, 48 year old female of the Town of Union; Bridgette Bensley, 41 year old female of the Town of Union; and Marie Newkirk, 50 year old female of the Town of Fenton for gang assault. All three females are accused of assaulting a female while at a local business in the Town of Union. As a result of the assault, the female suffered serious physical injury and extensive dental damage. All three females were arrested for Gang Assault in the 1st Degree, arraigned in a local criminal court, and released pending further court action.



DAVID L. COLSON



SEAN-COLLIN S. MCMAHON

On November 6, 2015, detectives arrested David L. Colson, 19 year old male of the Town of Union and Sean-Collin S. McMahon, 21 year old male of the Town of Union for robbery. Colson and McMahon are accused of entering the ExpressMart, located at 1015 Union Center Maine Highway in the Town of Union, armed with a shotgun and confronting the clerk in the back of the business. Colson and McMahon made the clerk open the cash register, stole the contents of the register, and then fled the business with an undisclosed amount of U.S. Currency. Colson and McMahon were each charged with one count of Robbery in the 1st Degree and one count of Criminal Possession of a Weapon in the 3rd Degree, both felonies, arraigned in a local criminal court, and remanded to the Broome County Sheriff's Office Correctional Facility pending further court action.

Broome County Special Investigations Unit Task Force



2016 MISSION

The *Broome County Special Investigations Unit Task Force* is a multi-jurisdictional task force primarily committed to the suppression of illegal and illicit drugs within Broome County. The Task Force actively pursues those individuals or groups who manufacture, distribute or sell illegal drugs within the jurisdictional boundaries of Broome County. In addition, the Task Force focuses on enforcing laws related to illegal firearms, prostitution, and Alcoholic Beverage Control Laws of the State of New York. The Task Force also conducts special operations including, but not limited to, homicides, extortion, robbery, larcenies, and counterfeit cases.

The Broome County Special Investigations Unit Task Force is comprised of sworn law enforcement officers from the Broome County Sheriff's Office, City of Binghamton Police Department, Village of Johnson City Police Department and the Endicott Police Department. Currently, the Broome County Sheriff's Office has a Detective Sergeant and five Detectives assigned to the Task Force; City of Binghamton Police Department has a Sergeant and six Investigators assigned to the Task Force; the Village of Johnson City Police Department has a Detective Sergeant and one Detective assigned to the Task Force; and the Village of Endicott Police Department has one Detective assigned to the Task Force. The total number of members assigned to the Task Force at the end of 2015 is 16. The Task Force is comprised of four separate agencies that also work closely with other local, state and federal law enforcement agencies. Thus, the mission of the Task Force is accomplished through the combined and coordinated enforcement efforts among the various law enforcement agencies working within or directly with the Task Force.

The Task Force accomplishes its mission by utilizing the following investigative techniques:

Surveillance Confidential Sources Search Warrants Eavesdropping Warrants Undercover Operations Patrol stops

Analysis of 2015 Goals & Objectives

At the beginning of 2015, members of the Task Force had established two goals to achieve during the year.

The Task Force will continue to increase efforts to arrange additional trainings throughout 2015. The purpose of such trainings will be to increase the abilities and overall skill level of Task Force Investigators in the areas of tactical competency as well as legally sufficient investigative methods, especially with the addition of newly assigned Task Force investigators.

Task Force supervisors will increase efforts to plan coordinated narcotics suppression and interdiction efforts in specific narcotics ridden problem areas throughout the Broome County area. This effort will not only assist in ridding suffering neighborhoods of criminals, but will also assist Task Force investigators in further building the database of cooperating, confidential informants. In addition, this will assist Task Force investigators in building more cases and will also aid in inside information of ongoing, open criminal investigations.

#1. One goal was to increase efforts to arrange for additional trainings throughout 2015, to increase the overall skill level of Task Force Investigators.

This goal was accomplished when Broome County Special Investigations Unit Task Force investigators attended trainings throughout the year to include; Undercover Officer Operations, Safety and Success sponsored by NY/NJ HIDTA (High Intensity Drug Trafficking Area), Drug and Alcohol Addiction and Causes/Drug and Alcohol Programs taught by the Broome County District Attorney's Office, Signs of Narcotics Use and Sales/Parole and Probation Programs sponsored by the Broome County Probation Department, and New World System Computer Database training sponsored by Broome County Office of Emergency Services, New World Systems and Broome County/City of Binghamton Information Technology Departments.

#2. The second goal was to increase efforts to plan coordinated narcotics suppression and interdiction efforts in specific narcotics ridden problem areas throughout the Broome County area

This goal was met throughout the 2015 year with coordinated and designated narcotics suppression details in the City of Binghamton, the Village of Johnson City, the Village of Endicott and rural areas in Broome County. These details resulted in numerous arrests, search warrants and the cultivation of further confidential informants. Many of these arrests were for quality of life issues, narcotics possession and narcotics transportation.

Task Force Goals for 2016

With the recent cessation of the federal DAG-71 asset forfeiture program, the Task Force will actively seek other avenues as a means of obtaining much needed equipment and funding, which are needed to combat and investigate the ongoing, illegal drug trade. The Task Force will work towards creating a professional liaison with the DA's Office in the area of stateside forfeiture proceedings of valuable assets, to include money, which can be shown to be proceeds from illegal narcotics sales; as well as vehicles that were used to transport and traffic narcotics in furtherance of narcotics related crimes.

In continuation of the professional liaison with the DA's Office, the Task Force will work towards facilitating further cooperation agreements with people who choose to assist the police in combatting the ever-increasing heroin epidemic, and overall illegal narcotics problem. This effort will not only assist in ridding suffering neighborhoods of criminals, but will also assist Task Force investigators in further building the database of cooperating, confidential informants. In addition, this will assist Task Force investigators in building more cases and will also aid in inside information of ongoing, open criminal investigations.









NOTABLE INVESTIGATIONS

Parolee arrested for large quantity of narcotics and a loaded handgun

Task Force investigators executed a narcotics search warrant in the City of Binghamton and locateD the resident in possession of 974 bags of heroin, 67 grams of unpackaged powder heroin, approximately 31 grams of crack cocaine, approximately 10 grams of powder cocaine, drug paraphernalia and a loaded Glock model 23, .40 caliber semi-automatic handgun. The arrestee was also found to be on Parole. He was charged with ten new charges, in addition to Violation of Parole.



Large Cocaine Seizure

Task Force members interrupted the sale of over 2 ¹/₂ ounces of crack cocaine to another person. The dealer was found to be in possession of the crack cocaine as he was arrested by Task Force investigators. He was charged with an A-I Felony, amongst other felony charges.

Town of Windsor search warrant yields heroin, methamphetamine, suboxone, prescription medications and narcotics packaging

The Task Force executed a narcotics search warrant in the Town of Windsor. The Windsor resident was found to be in possession of 70 bags of heroin packaged for sale, 4 zip lock baggies containing methamphetamine, 78 Suboxone strips each individually packaged for sale (a Schedule III controlled substance), numerous Subutex pills (a Schedule III controlled substance), narcotics packaging, a digital scale used to weigh narcotics and approximately \$7,700 in U.S. currency of suspected drug proceeds.

A loaded handgun, packaged and unpackaged heroin, cocaine and drug paraphernalia recovered at a local hotel

The Task Force executed a search warrant at a local hotel in the Town of Union and recovered a loaded Cobra .380 handgun, 167 bags of heroin, a foil container with loose heroin not packaged yet, a knotted plastic wrap of powder cocaine, digital scales, packaging materials, and \$567 in U.S. currency of suspected drug proceeds.

Powder cocaine, crack cocaine, heroin, ecstasy, meth and marijuana recovered

A Johnson City resident was arrested after a search warrant at her home uncovered approximately 3.5 grams of heroin, approximately 3.8 grams of crack cocaine, approximately 9.1 grams of powder cocaine, 43 knotted wraps of crack cocaine, several packets of heroin, a quantity of suspected MDMA (ecstasy), a quantity of suspected methamphetamine, approximately 6 ounces of marihuana, and various drug paraphernalia. Investigators also seized \$4,149.00 of U.S. Currency. The Task Force was assisted on scene by the Johnson City Police and the US Marshal's NY/NJ Regional Task Force. Another resident who was present and was arrested was found to be wanted by the Somerset County Prosecutor's Office in New Jersey for a Dangerous Drugs offense. He was arraigned as a Fugitive from Justice and was remanded to the Brome County Sheriff's Correctional Facility without bail.

Task Force assists local police at the scene of a Meth Lab

Task Force and NYSP CCSERT members work a meth lab in Johnson City after Johnson City patrol officers discovered what they suspected was a methamphetamine lab and evacuated the building. Members of the Broome County Special Investigations Unit Task Force and members of the New York State Police Contaminated Crime Scene Emergency Response Team responded to the scene and executed a search warrant on the apartment. Investigators located an active meth lab which was secured and the building was rendered safe. The resident was charged with numerous felony charges, to include an A-II Felony.

Wanted man found in possession of high grade methamphetamine, heroin and a large amount of cash

A City of Binghamton man was found in possession of 504 bags of heroin, 7.63 grams of high grade meth, and \$18,257.00 in U.S. currency. He was also wanted on a Parole Warrant and an active arrest warrant out of the City of Binghamton Court.

Powder Cocaine and Crack Cocaine

The Task Force executed a narcotics search warrant in the City of Binghamton. The apartment resident was found in possession of approximately 119 grams of powder cocaine and crack cocaine along with packaging material.

Two Brooklyn men found in possession of narcotics in hidden containers, as one man attempts to flee and fights with officers

In December the Task Force executed a narcotics search warrant in the City of Binghamton. Two Brooklyn men were arrested after the Task Force locateD 63 glassine envelopes of packaged heroin, approximately 9 grams of unpackaged heroin, 9 plastic knotted wraps containing crack cocaine, false/hidden containers, a digital scale, numerous items of drug packaging, protective face masks, drug paraphernalia and approximately \$1,600.00 in suspected drug proceeds. One of the two men attempted to flee fought with police officers on the scene. The Task Force was assisted by the Binghamton Police Department's Community Response Team.

Large heroin seizure

A search warrant in the Village of Endicott resulted in the seizure of 622 bags of packaged heroin, Suboxone which is a schedule III controlled substance, powder cocaine, crack cocaine, and marihuana. Investigators also recovered \$3,784.00 in U.S. currency which is suspected drug sale proceeds.

Multi-Agency joint heroin trafficking operation in and from Broome County area

A five month heroin trafficking investigation conducted by members of the Delaware County Sheriff's Office Criminal Investigation Division, Village of Sidney Police Department, Delaware County Probation Department and the Broome County Special Investigations Task Force focused on heroin trafficking in and from the City of Binghamton to the Town and Village of Sidney area.

Investigators arrested a Queens, New York, man on a felony drug possession charge following the execution of a search warrant in the Town of Sidney.

Investigators arrested another NYC man for Criminal Possession of a Controlled Substance (*possession with intent to sell*) and Criminal Possession of Marihuana after seizing 100 bags of heroin that he intended to sell from his vehicle while within the NYS DEC's public fishing access lot located in the Town of Sidney.

Sheriff's Deputies and Task Force Investigators were assisted at the search location by members of the New York State Police, Sidney, and Sidney Village Police Department.

Large narcotics seizure in the Town of Union

The Task Force executed a search warrant at an address on Union Center- Maine Highway in West Corners. Pursuant to the search warrant, investigators recovered:

Approximately 5.89 grams of methamphetamine Approximately 42 grams of powder heroin Approximately 8.18 grams of powder cocaine Approximately 5.35 grams of crack cocaine 20 glassine envelopes containing heroin 66 'Lortab' pills – a schedule II controlled substance 49 15 mg morphine pills – a schedule II controlled substance 8 Adderall pills – a schedule II controlled substance Numerous scales as well as packaging materials \$3,002.00 in suspected drug proceeds Prior to the execution of the search warrant at the residence, investigators located the target of the search warrant in a vehicle on Watson Blvd. He was taken into custody at that time without incident. Task Force members were assisted by Endicott Police patrol units. The target of this investigation was charged with: *10 counts* of Criminal Possession of a Controlled Substance in the Third Degree, class B Felonies, *4 counts* of Criminal Possession of a Controlled Substance in the Fourth Degree, Class C Felonies, *2 counts* of Criminal Possession of a Controlled Substance in the Seventh Degree, Class a Misdemeanors, *2 counts* of Criminally Using Drug Paraphernalia in The Second Degree, class A Misdemeanors and Violation of New York State Parole conditions.

Powder Cocaine with a street value of \$60,000.00 recovered in Binghamton

The Task Force concluded a month long investigation into the transportation of large amounts of heroin into the Broome County area. Three people were arrested after conspiring to transport large amounts of heroin and cocaine from New York City to the Broome County area.

At the bus depot in the City of Binghamton, Task Force investigators were able to successfully intercept approximately 130 grams of unpackaged, pure heroin and approximately 52 grams of powder cocaine with a combined approximate street value of \$60,000.00. Two of the three people were arrested as they exited a bus which was inbound from NYC and third was arrested at a separate location in the City of Binghamton. Two of the three were also wanted on active Arrest Warrants and one was on Parole.

Operation Broken Family

Nine men were charged with federal crimes in a gang-related drug trafficking conspiracy, after police raided 12 locations around Binghamton and Johnson City in November 2015. The joint investigation was conducted by members of the Broome County SIU Task Force, FBI and New York State Police SIU. The search warrants were the culmination of three months of intercepted wiretapped phone conversations, undercover drug buys, and confidential informants who bought narcotics from the defendants.

The raids were carried out by more than 100 law enforcement officers from the FBI, U.S. Marshals Service, New York State Police, Broome County Sheriff's Office, Vestal Police, Endicott Police and Johnson City Police and the Broome County SIU Task Force. Teams of officers included SWAT team members from the Broome County Sheriff's Office, Binghamton Police Department, New York State Police and FBI. The search warrants were executed simultaneously shortly after 6 a.m. Tuesday.

Arrested were; Johnson City resident Izabivone Hughes, 22; along with Binghamton residents Anthony Randolph, 29; Aalim M. Shabazz, 23; Rashawn C. Cauthen, 24; John P. Abbadessa, 21; Theodore J. Cook, 27; Jalon T. Parker, 23; Terrell S. Collins, 23; and Anthony E. Boyd, 24.

The defendants were involved with the "Eddie Block Gang," which is based around Edwards Street on Binghamton's West Side. They distributed large amounts of powder cocaine, crack cocaine, heroin, marijuana and percocet since January 2014.

They each face felony charges of drug trafficking conspiracy. Randolph also was charged with possession of a firearm by a convicted felon, also a felony.

The charges carry maximum sentences of life in federal prison.

Community Policing Division / School Resource Officer

The Community Policing Divisions is comprised of one full-time deputy. This deputy is responsible for all community service projects as well as serving as a School Resource Officer. The School Resource Officer program is a collaborative effort by certified law enforcement officers, educators, students, parents and the community to offer educational programs in the schools to reduce crime, drug abuse, and violence and provide a safe environment. It is the responsibility of the deputy to focus on the needs of the schools and assist the administration in accomplishing their goals. The School Resource Officer is committed to promoting a concept of school based law enforcement. This TRIAD concept allows the School Resource Officer to act as a teacher, counselor and law Enforcement officer. School Resource Officers work with students, parents and school staff on a daily basis. The deputy is required to develop and teach lessons to students on numerous subjects. Officers also assist students, parents, and staff as counselors. Counseling sessions may be for behavioral problems or for persons in crisis. The deputy talks to students regarding careers in law enforcement. The deputy also assists the school in their disaster planning issues. They conduct investigations of incidents in and around the school, and make any arrests as a result of these investigations. The Broome County Sheriff's School Resource Officer works in the Maine Endwell School District and the Chenango Valley School District. This partnership of law enforcement, school district, parents and the community, provides a safe and successful learning environment. At various times, the SRO will also assist other school districts that request assistance as well. In 2015, the Community Policing Office as well as other Deputies conducted numerous School Safety & Building Integrity Drills.

Neighborhood Watch Programs

The Broome County Sheriff's Office continues to work with the citizens within the County, helping them establish Neighborhood Watch groups. This program encourages citizens to be active within their neighborhood in preventing crime and assisting the police by being good observers in the community. The Broome County Sheriff's Office is involved with 27 Neighborhood Watch groups. The Sheriff's Office is directly linked to the National Neighborhood Watch, which is associated with the National Sheriff's Association. The Sheriff's Office also participates in National Night Out, which promotes neighborhood safety as a whole with an emphasizes on anti-crime issues. The most recent Neighborhood Watch Group has been in West Endicott, which has also encompassed a part of the Village of Endicott as well at the Town of Union. By far, this group has been the most proactive in 2015.



Safe Senior Programs

The community policing division educated many seniors this year on the issues of telemarketing fraud, investment scams, auto safety, and theft prevention. Programs were offered at local senior centers and housing and area churches. Many donations from area businesses provided the opportunity for the Sheriff's Office to purchase several hundred "Senior Safe" pamphlets that were distributed to various seniors in Broome County. The Sheriff's Office paired up with the New York State Sheriffs' Association and started the Yellow DOT Program in Broome County. Working with the Office for Aging, Department of Health and the NYS Sheriff's Association, the Sheriff's Office was able to distribute several thousand Yellow DOT stickers/packets to Broome County residents. The Yellow DOT is a decal placed on a driver's vehicle, and a yellow folder with the driver's vital medical information in the event of an emergency is placed in the glove compartment. The Yellow DOT Program is free and is provided by the NYS Sheriff's Association.



Traffic Safety Grants

The Community Policing Office authored two grants for the 2015 year. These grants, provided through the Governor's Traffic Safety Committee, totaled **\$19,800**. They included funding for Police Traffic Services and Motorcycle Safety which resulted in additional patrol hours on Broome County highways. Deputies used these hours to curb aggressive driving habits to lower motor vehicle accidents caused by aggressive driving. The grant is derived from using agency specific crash and enforcement data to show where the most need for enforcement is in the county. Many areas were targeted specifically on complaints from citizens, as well as accident data and data collected from strategically posted speed trailers that record traffic activity. The motorcycle safety grant allowed Deputies to educate motorists about being aware of motorcycles on the roadway, but also assisted in education of motorcycle riders themselves as well. Many public motorcycle functions allowed for Deputies to interact with more riders and provide safety information. All motorcycle safety activity was conducted by the Sheriff's Highway Patrol Motor Officers themselves.

Social Media Outreach – Facebook/Mobile Patrol/Twitter

The Broome County Sheriff's Office started its own Facebook page in 2012, and it has evolved into a vital part of community outreach. The page has allowed the Sheriff's Office to post press releases, recent arrests, motor vehicle accidents, missing persons, road closures, home and personal safety tips, as well as other law enforcement topics and information. The Facebook page has allowed the Sheriff's Office to interact with the community on a more personal level, and often updates them faster than the newspaper or television. The Facebook page has aided in numerous cases, resulting in identifying suspects of crimes and assisting in finding missing persons. In 2013, the Sheriff's Office adopted a free smart phone application called "Mobile Patrol." Users are able to view live access to jail information and see the most recent bookings listed chronologically, search by first and last name, age and gender, as well as alphabetically. Users can also see a full list of real-time warrants (including child support), each with the ability to be shared on social media so the community can help law enforcement apprehend wanted individuals. Registered sex offenders in the community are viewable, including mug shots, charges, and mapping of their city block. Users can easily report crime tips directly to the Sheriff's Office. This feature is also integrated throughout the warrant listings; therefore users may easily report a sighting of a wanted person. In 2015, the Sheriff's Office also created an Official Twitter page (@BroomeSheriff). Much of the information that is posted onto Facebook is also posted on the Twitter page. We've discovered various age groups use both Social Media

platforms and wanted to ensure we could reach as many residents as possible. Numerous investigations have been assisted with the help from the public, based on social media posts.



Project Lifesaver

In 2015, The Broome County Sheriff's Office started a new program in collaboration with Project Lifesaver International and the New York State Center for Missing and Exploited Children. Project Lifesaver consists of members of the Sheriff's Office being specially trained with equipment to help find missing people with certain ailments such as Alzheimer's, Dementia, Traumatic Brain Injury, Down Syndrome, and Autism. These ailments can cause people to have a risk of wandering, which increases their risk of becoming injured, ill or even more severe consequences. Families or Caregivers of "Clients" apply through the Sheriff's Office, and if approved, they receive a specialized bracelet that has a radio transmitter inside. This transmitter has a specific frequency per Client and can be traced by a receiver, operated by a Deputy Sheriff. Each family receives training on how to use the bracelet and what to do in the event that their loved one goes missing. All equipment was paid for by a grant given to the NYS Center for Missing and Exploited Children – and in turn was given to the Sheriff's Office. A vast majority of NYS Sheriff's Offices now participate in this program.


Speed Trailers and Statistics

The Sheriff's Office has two portable Speed Trailers with a variable message sign mounted. These trailers are powered completely by a solar panel mounted on top. The speed of oncoming vehicles can be displayed to passing vehicles. The more valuable information is the traffic statistics recorded by such speed sign. These statistics are reviewed and priority for traffic/speed enforcement is then determined after the removal of the sign. Many residents complain of speeding vehicles near their home or business and these signs have been a great asset in determining the need for traffic enforcement in the areas. All traffic statistics are able to be reviewed by any Deputy in roll call. Deputies can then prioritize where and when they are going to conduct traffic enforcement based on this information. In 2015, a smaller pole mounted sign was purchased and is going to be used for School Zones. This sign is portable and is also powered by a solar panel. This smaller sign will stay mounted longer and is used primarily to slow and calm traffic in school zones.



Law Enforcement Training Division

The Broome County Sheriff's Law Enforcement Training Division is the home to the New York State Zone 6 Law Enforcement Academy. The Zone 6 Academy provides training for more than 40 police agencies in 7 counties. Those 7 Counties are Broome, Chenango, Cortland, Delaware, Tioga, Tompkins and Otsego. The Training Division provides a wide range of in-service training for veteran law enforcement personnel as well as the Basic Course for law enforcement to train newly hired law enforcement officers. Of recent years, the Basic Academy has been receiving newly hired law enforcement officers from outside the zone. Some of those additional counties receiving training are Chemung, Yates, Seneca and Jefferson County.

The Broome County Sheriff's Law Enforcement Academy is regarded as a premier New York State Basic Police Officer Academy. We involve a great number of instructors from a wide variety of different agencies and disciplines that instruct at the Academy. The Academy is organized in a para-military fashion and provides more certifications than most of the Academies in New York State, while maintaining a very low cost for attendance. The 2015 Academy consisted of 1,384 hours of training and the 2015 Academy session graduated 44 recruits from 14 different agencies.

Throughout 2015, the Law Enforcement Training Division sponsored or assigned countless training hours for several hundred sworn law enforcement officers. The following are examples of the various different types of training:

The Training Division also conducted 32 hours of In-service Training for multiple Broome County Law Enforcement personnel; Broome County Sheriff's Office, SUNY Binghamton Police Department, Endicott Police Department, SUNY Broome Campus Safety and Port Dickinson Police Department. The training included:

Because of our ongoing positive relationship with the New York State Division of Criminal Justice Services, most of the training was conducted at no cost. The training division regularly receives compliments by their staff, as well as instructors and visitors participating in the DCJS training. The training division is comprised of one full time Highway Patrol Sergeant and many part-time instructors from various agencies.



CORRECTION DIVISION

Over the past fifteen years, a significant shift has occurred in the correctional systems in the United States. Changes in sentencing policies, and the public's attitude toward corrections, burgeoning inmate populations, closing of mental health and downsizing of state prison facilities, and a violent offender, all have combined to make corrections professionals reexamine the way they do business.

Legislators and the general public are requiring a greater level of efficiency and accountability by corrections' administrators as a larger proportion of tax dollars is going to support jail facilities and programs. Correctional systems are moving toward business management practices that include greater responsiveness to constituent concerns and sensitivity to the communities that surround their correctional facilities.

Based on the trends noted, the Administration was able to secure funding at no cost to the county to complete a \$630,000 upgrade to the BlackCreek Security System for the entire facility. This upgraded system will provide the necessary platform needed for future expansion of our facility and programs. Additionally, we purchased two new transportation vans for use on the weekend community work program.

Corrections Training Unit

The Corrections Training Unit of the Broome County Sheriff's Office was staffed by Sergeant James Guinan. Since the Corrections Profession is continuing to change, the Corrections Training Unit has endeavored to meet these changes. The 320 hour Basic Course for Corrections graduated 19 officers from 4 different counties. The training unit certified 4 new CPR instructors and 5 firearm instructors who will assist during academy and annual in-service training. The training for the Emergency Response Team continued to be directed at the always present threat of physical violence within the correctional facility. Annual in-service training is important to update officers to law changes, gang awareness and managing special needs inmates, just to name a few.

Medical Services

The Health Services Unit of the Correctional Facility has a comprehensive medical unit approach that combines both the medical services and forensic mental health service under one provider. Correctional Medical Care is contracted with the county to provide these services. The facility and county has benefited by this continuity of care. The unit is working very well in meeting the demanding needs of a growing population, while continuing to control costs.

The unit has worked hard in maintaining the high level of services demanded by the Sheriff's Office. Both the medical and mental health units are accredited by the National Commission on Correctional Health Care (NCCHC). Accreditation is the process of external peer review in which NCCHC, a private, not-for-profit organization, grants public recognition to correctional institutions that meet its nationally accepted Standards for Health Services. Through the accreditation process, NCCHC renders a professional judgment regarding health services provided and assists correctional facilities in their continued improvement

Corrections Criminal Investigations Unit

The Criminal Investigations Unit (CIU) is a sub unit of the Corrections Division, made up of select officers trained as investigators. These officers receive two weeks of criminal investigations training as well as periodic specialized training in areas that are relevant to their duties. Currently, there are ten officers assigned to the unit. Sergeant William Brown oversees the unit.

CIU is tasked with the responsibility of investigating any criminal activity that may occur within the Sheriff's Correctional Facility. Results of the investigation often result in the arrest and prosecution of the perpetrators. The unit is also responsible for the collection, verification, and dissemination of gang intelligence as well as maintaining the Sheriff's Gang Database. This database is a resource for county wide law enforcement on gang activity and gang intelligence.

The unit also functions as an arm of Criminal Intelligence, assisting local Detective Divisions and other police agencies with relevant information for ongoing investigations or identification purposes.

The following is a breakdown of the unit's activity for the year 2015.

65 Total Criminal Cases:

- 59 Closed by Arrest
- 6 Closed by Investigation

Total Number of Charges: 34 Felonies

- 33 Misdemeanors
- 0 Violation

The total charges are not mutually exclusive. Charges can overlap on the same criminal act. For instance, an inmate may have had felony and misdemeanor charges on the same arrest.

Warning Letters Written:

These letters are sent to prisoners warning them to cease all contact with persons who are being harassed or annoyed by them. There were a total of seven warning letters issued. This letter is sent prior to opening a Harassment charge against the prisoner.

Security Risk Group/Gang Management:

Part of the responsibility of the Correction Investigations Unit is to proactively collect, evaluate and disseminate security related gang intelligence that exists among the offender population. The unit works closely with law enforcement agencies in gang related crimes, not only to prevent potentially dangerous incidents within the correctional facility, but also as a proven benefit to public safety. In 2015, we housed inmates who had gang affiliations with such groups as the Bloods, Crips, Latin Kings, Arian Nation, Neta's, and Outlaw Motorcycle Gangs. Members of the unit interviewed 91 security risk group affiliates. The individuals interviewed were entered into the county wide Security Risk Group data base which is maintained by the Correction Investigations Unit.


Employment Background Investigations Conducted:

Sgt. Brown is tasked with conducting background investigations on all potential new officer hires and civilian employees for the Corrections Division. Further, he is responsible for all divisional internal investigations, acting as Internal Affairs for the Corrections Division. The Captain and Major of the division are in direct command of these responsibilities. There were a total of 23 employment background investigations conducted. Fourteen officers were hired as a result of the background investigations.

INMATE DISCIPLINARY PROCESS

The position of hearing officer is vital to the safe and secure operation of the facility. The staff that makes up the team ranges from the line officer, the programs Sgt., security lieutenants, and the jail administrator. This structure provides for timely assessment of the inmates actions along with lawful due process. Jails must be able to respond to an infraction of their rules quickly and decisively. But the courts insist that the disciplinary process follow certain steps, it does not require courtroom-like formality. A process respected by both staff and inmates alike benefits the institution.

The following charts represent the total hearings conducted and the disciplinary charges that inmates pled guilty too and waived their right to a formal discipline hearing.



INMATE GRIEVANCE PROGRAM


In order to provide an effective and impartial procedure for the timely resolution of inmate complaints, the chief administrative officer of each local correctional facility shall establish, implement and maintain a formal inmate grievance program. Every effort shall be made to resolve inmate complaints in an informal manner.

The term "grievance" is defined as a written inmate complaint concerning either written or unwritten facility policies, procedures, rules, practices, programs or the action or inaction of any person within the facility. Dispositions, surcharges, and sanctions resulting from disciplinary hearings and administrative segregation housing decisions cannot be the subject of a grievance. The chief administrative officer or his designee ensures that each grievance is investigated to the extent necessary by an impartial person. Failure to supply sufficient information or evidence within two days shall be cause to deny the grievance. Grievances regarding dispositions or sanctions from disciplinary hearings, administrative segregation housing decisions, issues that are outside the authority of the chief administrative officer to control, or complaints pertaining to an inmate other that the inmate actually filing the grievance are not grievable and may be returned to the inmate by the grievance coordinator. Such grievances may not be appealed to the chief administrative officer or the Citizens' Policy and Complaint Review Council (Appeal to the Commission of Correction). A copy shall also be given to the members of the Council for their review. If such determination is in favor of the grievant as a matter of law, the chairperson of the Citizens' Policy and Complaint Review Council shall direct the chief administrative officer to comply with the grievance and provide an appropriate remedy.

Weekender Work Program

The Weekend Work Program continues to provide a valuable asset to the Broome County community. This is fulfilled by using county sentenced inmates in community service operations in Broome County. Some inmates are sentenced to weekends only. They report to the correctional facility on Saturday & Sunday at 7:00 am and are finished at 3:00 pm, at which time they go home. They do this every weekend until the sentence the court gave them is completed. When an inmate is sentenced by the court to work on the program, instead of serving their sentence in the jail they report to the correctional facility and go out to work with an officer in a designated area within the county. They sign an agreement in court to follow all the rules given to them, or they risk being violated by the court and resentenced to what is called straight time. Straight time is when they would have to serve their entire sentence in the correctional facility. Not having inmates in facility for lesser charges helps to save the county money. This is accomplished several ways. First, there is no expense by not having to board the inmates in the facility. Second, the inmate does not lose the job they may already have thus making them more productive in society. The weekender work program is a program available to any "not-forprofit" groups in Broome County. By having this program it has helped put back valuable hours of labor into the community from individuals who have committed minor crimes therefore being cost effective by not having to pay employees to accomplish this work.

IDENTIFICATION DIVISION



The Identification Division is responsible for the maintenance of criminal records of the Broome County Sheriff's Office. The Division provides numerous services to the public as well. These services include; fingerprinting for adoptions, permits, job applications, security clearances, issuance of personal identification cards, records checks for several Broome County agencies, arson background checks for volunteer firefighters, registration of sex offenders within Broome County and the maintenance of the sex offender registry, Maintains & Supervise Central New York Live Scan Fingerprint database and submissions. Contained within the Identification Division is the Pistol Permit Office, which handles all aspects of issuance and maintenance of pistol permits for the public. This Division is staffed as follows:

CIVIL DIVISION

The Civil Division of the Broome County Sheriff's Office is staffed by the following personnel:

1 Chief Civil Deputy

2 Civil Deputies

3 Keyboard specialists

The Broome County Sheriff's Office Civil Enforcement Division is responsible for the service and enforcement of all civil processes in Broome County which include summonses, property executions, evictions, subpoenas and various other legal papers. The Courts throughout Broome, other counties in New York State and any state that requests our services depend on our Deputies to handle matters received from their various towns, cities, supreme, surrogates and family courts. Our division also receives orders of protection, summonses, petitions and other orders from various courts throughout the United States for emergency service or enforcement.

In 2015, the Civil Division processed 6,509 cases which include 898 summonses, 1,268 evictions (257 more than 2014) and 1720 family court services which involve neglect, juvenile delinquency cases, child support petitions, orders of protection, sexual abuse petitions, modification hearings and other kinds of orders and petitions. A more detailed breakdown is included in this report. Our total services decreased by 514 from 2015.

When attempting to affect services or enforce court orders, our Deputies spend vast amounts of time investigating and locating people. Wrong addresses, locations, descriptors or other information are often given to the deputies which results in time to locate individuals and businesses to affect service or to enforce court orders. At times Deputies will check with a local post office, friends of a respondent/defendant, former employers, petitioners, Broome County Department of Social Services, local and state courts, attorneys and other police agencies to locate people. As a result of the additional efforts by the deputies there were 87 fewer returns than 2014 totaling only 247 returns for 2015.

The Civil enforcement division handles numerous warrants of evictions for Broome County. The process for enforcing an eviction includes the Deputies overseeing the actual removal of a tenant's property. It would also include the enforcement of the warrant while considering both the landlord and the tenants' rights and ensure that proper procedures and laws are being followed. Depending on the situation, a deputy may spend hours or a full day on each eviction. On the occasion of enforcing a warrant for a business such as a restaurant or an established business, our Deputies have spent many hours and at times multiple days assuring the removal of equipment, furniture and inventory.


In 2015, revenues brought in for services were \$171,832.30 for Sheriff Fee's including mileage, an increase of \$15,878.49 from the previous year. \$170,612.69 was collected for poundage totaling \$342, 444.99, an increase of \$14,173.55 over the last year. This money is all turned over to Broome County. The Civil Division took in a total amount of \$469,759.99. This includes money collected and dispersed to Judgment Creditors.





FISCAL OFFICE 2015



The Fiscal Office staff includes the following personnel:

One Fiscal Manager One Principal Account Clerk One Senior Account Clerk/Typist

The Fiscal Office performs many traditional financial functions for the Sheriff's Office including, but not limited to, the following major items:

Processing bi-weekly payroll and maintaining all payroll records for the Sheriff's Office's approximately 250 employees in accordance with county policies and labor contracts. This involves weekly auditing and inputting all time and attendance data including overtime, shift premium, vacation and sick time. A separate attendance file is kept for each employee and updated weekly.

Processing supply requisitions and vendor payments (claim vouchers) for goods and services provided to the Sheriff's Office. Expenses are monitored against the approved annual budget using a separate Excel program, providing up-to-date expenditure data for financial decision

making. In 2015, 1,080 claim vouchers were processed, an increase of 5.5% over the previous year.

In concert with the Purchasing and Law Departments, the Fiscal Office monitors the status of various procurement contracts as required by the county charter and takes appropriate actions to renew existing contracts annually or to establish new contracts through the County's bid or RFP process.

With the assistance of the appropriate department heads, the Fiscal Office prepares the Sheriff's Office annual operating and capital budgets and monitors subsequent financial activity to assure compliance to the approved budget.

Grant development, monitoring and reporting. During 2015, the Sheriff's Office received \$216,534 of Federal and state grant funds which made possible additional staff and equipment purchases to support and enhance the capabilities of the Sheriff's Office.

Bails and fines, which are collected daily and subsequently remitted to the appropriate court twice each month, are processed. In 2015, 509 bails totaling \$498,535 were processed by the Fiscal Office.

Monitoring daily cash receipts and twice-monthly disbursements for garnishments and judgments processed by the Civil Office. The Fiscal Office also maintains records of activity within the Pistol Permits & Identification Funds, and Records Fund.

Daily processing of all inmate funds. Funds received from or on behalf of inmates are deposited daily to each inmate's account using the Swanson Services Corporation COBRA Banking System. Inmates may use these funds to purchase personal commissary items from Swanson Services Corporation. In 2015, \$598,784 was received through the inmate funds account and \$592,392 was disbursed.

As noted above, Swanson Services Corporation processes and delivers all commissary orders to the Public Safety Facility for distribution to inmates, thereby minimizing inventory shortages and employee expenses. Receipts of \$154,563 were processed through the commissary funds account and \$202,513 was disbursed in 2015. Net commissary sales in 2015 were \$456,170 and commissions received from these sales were \$150,709. Commissions are used to purchase items for the benefit of inmates such as newspaper and magazine subscriptions, law books and cable television service.

RECORDS DIVISION

The Records Division of the Broome County Sheriff's Office records and maintains all official records and documents relative to the police operations of the Broome County Sheriff's Office. This Division is responsible for entering all Incident/Case and Accident Reports investigated by the officers of the Broome County Sheriff's Office into the Records Management System and filing monthly reports to the Division of Criminal Justice Services in Albany using the Incident Based Reporting System. Personnel assigned to the Records Division are:

2 Keyboard Specialists 1 Clerk (part-time)

This Division provides records for the District Attorney's Office, the Department of Social Services, Probation Offices, The New York State Parole Office, as well as many out of state departments. This office also provides the public with copies of Motor Vehicle Accident Reports, New York State Incident Reports, and photographs. We now offer the public the opportunity to purchase Motor Vehicle Accident Reports on-line. Accident Reports and theft reports are also available through the Records Office at a fee of .25 cents per page. It is required that more sensitive reports be requested through the County Freedom of Information Office. In 2015, the Records Division processed 437 Freedom of Information Requests and provided over 4,150 reports to several other agencies, including those listed above.

Additionally, the Records Division is responsible for providing an alarm permit to the residents and businesses in our jurisdiction who maintain a burglar alarm on their premises. This Division also maintains an account of all avoidable alarms occurring at these locations, and provides billing as required. There is no fee for an alarm permit; however, fees are charged for excessive avoidable alarms within each calendar year. A breakdown of these fees is listed below:
